4. FIRST AID MEASURES

4.1 Description of first-aid measures

General advice

Move out of dangerous area. Consult a physician. Show this safety sheet to the doctor in attendance.

lf inhaled

Remove victim to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

In case of skin contact

Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes.

In case of eye contact

Immediately flush eyes with plenty of water for at least 15 minutes. Ensure adequate flushing of the eyes by separating the eyelids with fingers.

If swallowed

Do not induce vomiting. Never give anything by mouth to an unconscious person. Allow victim to rinse his mouth with water. Allow victim to drink 2 – 4 cupfuls of water. Call Poison Control center.

4.2 Most important symptoms and effects, both acute and delayed

Inhalation: Coughing, wheezing, sneezing, shortness of breath.

Eyes: Redness, discomfort. Skin: Redness, itching. Ingestion: Nausea, vomiting.

5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Water spray, carbon dioxide, dry chemical powder, or polymer foam. Do not use water with a full water jet.

Releases toxic fumes of carbon oxides and hydrogen fluoride.

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment, and emergency measures

Use personal protective equipment. Avoid breathing vapors, mist, or gas. Ensure adequate ventilation. Keep people away from and upwind of spill/ leak. Restrict access to area until completion of clean-up.

6.2 Environmental precautions

Prevent further leakage or spillage if safe to do so. Do not allow material to enter drains. If necessary, dike ahead of spill to prevent runoff into drains, sewers, or any natural waterway or drinking supply. Persistent organic pollutant.

7. HANDLING AND STORAGE

7.1 Precautions for safe handling

Do not handle until all safety precautions have been read and understood. Wear protective gloves and eye/face protection. Use only in well-ventilated areas. Handle in fume hood. Mechanical exhaust required. Avoid prolonged or repeated exposure. Avoid inhalation of vapor or mist. Avoid contact with skin, eyes, and clothing. Keep away from heat and open flames. Do not eat, drink, or smoke when using this product. Wash hands thoroughly after handling.

Keep cold. Keep container tightly closed. Store in cool, dry, and well-ventilated place. Keep away from direct sunlight or heat sources. Empty containers retain residue (powder and/or vapor) and can be dangerous. Store and handle in accordance with all current regulations and standards. Keep separated from incompatible substances (see § 10.5).
