4. FIRST AID MEASURES

4.1 Description of first-aid measures

General advice

Move out of dangerous area. Consult a physician. Show this safety sheet to the doctor in attendance.

If inhaled

Remove victim to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.

In case of skin contact

Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes.

In case of eye contact

Immediately flush eyes with plenty of water for at least 15 minutes. Ensure adequate flushing of the eyes by separating the eyelids with fingers.

If swallowed

Do not induce vomiting. Never give anything by mouth to an unconscious person. Allow victim to rinse his mouth with water. Allow victim to drink 2 – 4 cupfuls of water. Call Poison Control center.

4.2 Most important symptoms and effects, both acute and delayed

Inhalation: Coughing, wheezing, sneezing, shortness of breath.

Eyes: Redness, discomfort.

Skin: Redness, itching.

Ingestion: Nausea, vomiting.

Note to physician: Treat symptomatically and supportively.

5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Water spray, carbon dioxide, dry chemical powder, or alcohol-resistant foam.

5.2 Special hazards arising from the substance or mixture
Releases toxic fumes of carbon oxides and hydrogen fluoride.

5.3 Advice for firefighters
Wear self-contained breathing apparatus for firefighting if necessary. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment, and emergency measures
Use personal protective equipment. Avoid breathing vapors, mist, or gas. Ensure adequate ventilation. Keep people away from and upwind of spill/ leak. Restrict access to area until completion of clean-up.

6.2 Environmental precautions
Prevent further leakage or spillage if safe to do so. Do not allow material to enter drains. If necessary, dike ahead of spill to prevent runoff into drains, sewers, or any natural waterway or drinking supply. Persistent organic pollutant.

6.3 Methods and materials for containment and cleaning up
Soak up the spill with an inert absorbent material, such as dry-lime, sand, vermiculite, or soda ash. Contaminated absorbent material may pose the same hazards as the spilled product. Place in container for disposal according to local regulations.

7. HANDLING AND STORAGE

7.1 Precautions for safe handling
For precautions, see § 2.2.
Do not handle until all safety precautions have been read and understood. Wear protective gloves and eye/face protection. Use only in well-ventilated areas. Handle in fume hood. Mechanical exhaust required. Avoid prolonged or repeated exposure. Avoid inhalation of vapor or mist. Avoid contact with skin, eyes, and clothing. Keep away from heat and open flames. Do not eat, drink, or smoke when using this product. Wash hands thoroughly after handling.

7.2 Conditions for safe storage, including any incompatibilities
Keep container tightly closed. Store in cool, dry, and well-ventilated place. Empty containers retain residue (powder and/or vapor) and can be dangerous. Containers which are opened must be carefully resealed and kept upright to prevent leakage.

Store and handle in accordance with all current regulations and standards. Keep separated from incompatible substances (see § 10.5).

Handle and store under inert gas. Light sensitive. Heat sensitive. Air sensitive. Hygroscopic.

Appropriate engineering controls
