**WARRANTY:** Thank you for choosing to purchase a sprouting unit from Simply Country, a fine product that has received the care that quality demands. This warranty information is indicative of our desire to stand behind our product and assure our customer's complete satisfaction.

Simply Country, Inc (warrantor) warrants to the ORIGINAL purchaser for a period of 90 days, that the body structure of the unit will be free of substantial defects in materials and workmanship attributable to the Warrantor. Should warranty service be required, parts will be covered by the Warrantor for 90 days from the purchase date.

**Exclusions from this warranty:** Warrantor expressly disclaims any responsibility for damage due to normal wear and tear. Events discharging warrantor from obligation; misuse or neglect, including failure to provide reasonable maintenance, unauthorized alteration, accident, or act of God, shall discharge Warrantor from any obligation under this warranty.

**Purchase Responsibilities:** Purchase must provide specified electrical and water supply. 110V/20A circuits are required for the ECO 110 and ECO 220 systems. All costs associated with shipping and unloading are to be borne by the purchaser. ECO 110 and ECO 220 systems require a forklift with extended forks to unload. Failure to provide proper unloading equipment shall be treated as misuse and/or neglect.

**Warrantor's Obligation:** Warrantor will remedy substantial defects in materials and workmanship caused by the warrantor. Warrantor shall elect to remedy from among the following: repair, replacement, or refund.

**Parts and Design Changes:** Warrantor reserves the right to change the parts and/or design of the unit from time to time without any notice and with no obligation to maintain spare parts or make corresponding changes in its products previously manufactured.

**Owner Assistance:** Your personal satisfaction and goodwill are most important to Simply Country as well as a pleasant and confident relationship. If a need for warranty service arises, please contact the warrantor by mail, email, or phone.

**IMPORTANT!** Simply Country systems have a drain at the harvest end. Although most water will exit through this drain, they are not designed to be 100% water tight. The floor or ground surrounding the systems may get wet.

Quality seed is critical to proper growth. We recommend using seed grade barley, wheat, etc. Un-cleaned seed, field run seed, etc. may not be viable. Germination tests when possible are recommended.
