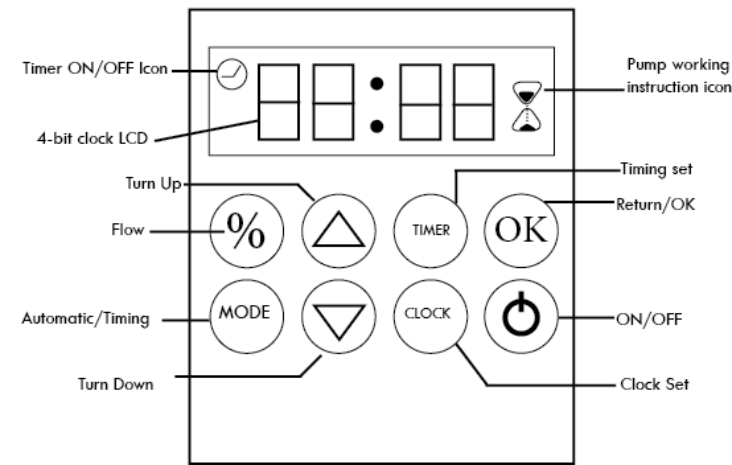

Operation

- Mode: this cycles between manual and your timer settings
- OK key: Press this after any changes to save your settings.
- Clock: Setting your current time, after pressing the clock key, set the time with the Up key and the Down key. Set the hour and then press clock again to change the minutes. Press the OK key after you have set it correctly to your time.
- Timer: Press the Timer key and the timing function icon will turn on. Then press the clock button to set your first timer. Repeat the operation to set up to 6 other timer settings total. Repeatedly press timer to cycle between the 6 timers.
- Timer Off: Set the off timer settings in the same way. Pressing timer will cycle between Timer 1 On Timer 1 Off, Timer 2 On, Timer 2 Off, etc.
- %: Power Setting Key. Use this button to set your flow, press % key to set flow by UP key and Down key, ranges vary between 50%-99%. After that, press OK key to save and run.
- ON/OFF key: In automatic mode, this will start and stop the pump.
- Power on: If the display is asleep, press the power key. This will turn the remote on and restore the settings before the remote went asleep. When the remote wakes up it will send time, flow, automatic/timing data. In timing mode, it performs the start-up, or stop command according whether it is running.
- Sleep: The remote enters sleep after no operation for 30 seconds.
- Press the "CLOCK" key to set the time you want your timer to start the pump. When the time is not set, it displays "--:--". Press the "CLOCK" key again and the hour icon flashes, and the current time point can be set by pressing the "Up" or the "Down" key. Then press the "CLOCK" key, the minute icon flashes, and press the "Up" or "Down" key to set the current minute. The hour and minute both should be set. Press the "OK" key to save the time period.

Troubleshooting

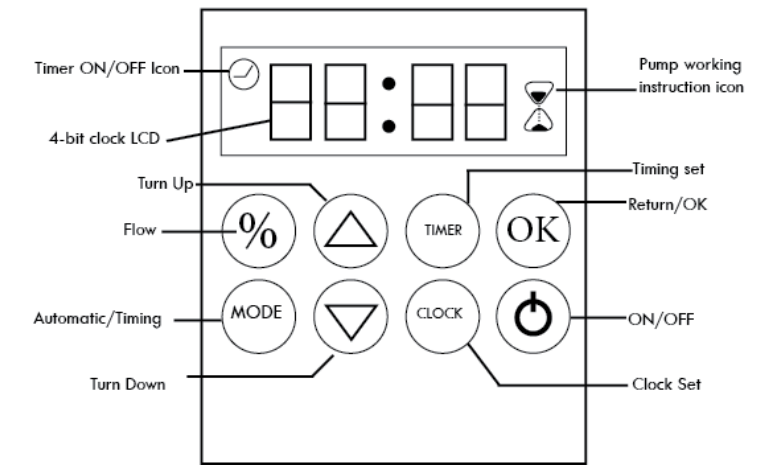
If your pump fails to start, try cycling between the power levels on the remote. Sometimes, pumps will not start up if the wattage is not sufficient.
