THERMOSTATIC SANITARY TRAP INSTALLATION INSTRUCTIONS

TYPICAL APPLICATIONS

Clean steam for powering sterilizers and autoclaves.

Culinary steam for direct cooking and heating of foods.

Clean steam for humidification of clean rooms.

Pure steam for sterilization of equipment in the biotechnology and pharmaceutical industries.

INSTALLATION

Observe pressure limitations shown on trap label.

To provide for easy maintenance and service, install an isolation valve ahead of the trap.

All valves should be full ported to achieve the rated capacity of the trap.

Install trap below the equipment being drained in a location easily accessible for maintenance and inspection. Be certain the flow arrow on the trap points in the proper direction.

After clamping trap into system, flush system thoroughly to eliminate any contamination.

Discharge piping should be amply sized to avoid excess back pressure.

A dirt leg with a trap station is recommended at every change of elevation. There should be no undrainable pockets.

It is recommended no other steam service be interconnected with a Clean Steam service.

MAINTENANCE

Isolate trap from both supply and return line pressures.

Wait until trap is cool enough to be safely handled.

Remove trap from the line.

Remove the element assembly, inspect seating area of ball valve and seat. If the ball valve is worn or damaged, order parts kit #500-02. If the seat in the Body Outlet is worn, replace the entire trap.

Reinstall thermal assembly with a new body gasket, kit #500-01.




ORDERING SPARE PARTS
