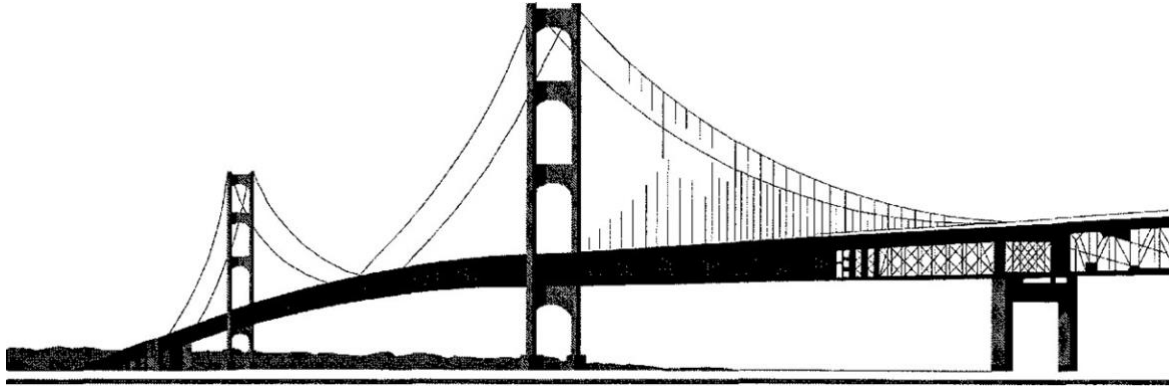


**Mackinac Bridge Authority**  
**Liability Disclaimer/Hold Harmless Agreement**  
**Used Deck Grating**

The used steel open grating deck sections removed from the Mackinac Bridge have been painted with lead-based paint. This coating exists on the grating at the time of removal from the bridge and at the time of sale of the grating. The remaining components of the existing paint on the grating are unknown. The grating is being removed from the Mackinac Bridge due to its deterioration in the form of corrosion and steel section loss. The strength capacity of the grating at the time of removal from the bridge is unknown.

I am the buyer of the used grating pieces and I am authorized to sign this Liability Disclaimer/Hold Harmless Agreement. (Little Traverse Tileworks has signed and by purchasing this piece you understand/are aware of everything in this document).

I understand that the used grating is painted with lead-based paint. I understand that the lead paint is considered a hazardous material. I understand that wastes that are deemed hazardous must be properly stored, treated, and disposed of in accordance with the Federal Resource Conservation and Recovery Act (RCRA). I understand that the remaining components in the existing paint on the grating are unknown. I understand that there is no known or implied structural strength capacity of the grating sections. I also understand that the State of Michigan, the Mackinac Bridge Authority, its agents, and employees are not assuming any obligation with regard to the grating conditions and specifically disclaim any and all liability arising from the grating conditions and any involved with the use, resale or disposal of the grating sections once they are in my ownership.

As consideration for the purchase of the used grating sections removed from the Mackinac Bridge, I agree to accept and assume all (100%) of the risk involved in owning, using, reselling and disposing of the grating sections, and in doing so, specifically acquit, relieve, exempt and release the State of Michigan, the Mackinac Bridge Authority, its agents and employees (and Little Traverse Tileworks and its agents and employees) from any and all claims for injury, illness, accident or damages sustained or occasioned by the use or disposal of the grating sections, whether due to my own negligence, the negligence of others or the negligence of the State of Michigan, the Mackinac Bridge Authority, its agents or employees, (and Little Traverse Tileworks and its agents and employees).

I also indemnify, hold harmless, and accept all responsibility, and will defend the State of Michigan, the Mackinac Bridge Authority, its agents, and employees (and Little Traverse Tileworks and its agents and employees) from any liability of damages for injury or illness to person(s) or property occasioned by any negligence by me in connection with the use, resale or disposal of the grating sections.
