USING THE FLASHLIGHT

- 1. Press the tail switch button (6), to power on the unit. The Power Indicator LED's (8) will turn on.
- 2. Press the light activation button (5). The flashlight will come on either High, Medium, Low, or Strobe Mode.
- 3. To change to another light mode press the light button (5) again.
- **4.** To turn the flashlight off press and hold the light button (5).
- **5.** To power off the unit press the tail switch button (6).

Caution: When the flashlight is on, pressing the stun activation button (4) will activate the stun gun to allow you to quickly defend yourself at night. Be careful not to press this button by accident when the unit is powered on or when you are using the flashlight.

TESTING THE STUN GUN

We recommend test firing the stun gun and becoming familiar with its operation before you need to use it to defend yourself. (**WARNING**: Do not test fire the stun gun for more than 1 second as this will damage the unit and void the warranty.)

- 1. Press the tail switch button (6), to power on the unit. The Power Indicator LED's (8) will turn on.
- **2.** Press the Stun Activation Button (4) to test fire the unit. Do not hold down the button for more than 1 second. You will see and hear a charge fire across the top of the unit between the contract probes (1).
- **3.** To power off the unit press the tail switch button (6).

USING THE STUN GUN IN SELF DEFENSE

- 1. Optional: Insert the lanyard's small loop through the Lanyard Hole (7) and then pull the wrist strap through.
- 2. Press the On/Off Tail Switch (6), to power on the unit.
- **3.** Touch your assailant's body with the contact probes (1) and press the stun activation button (4).
- **4.** Touching anywhere on the assailant's body will have an effect. However, the maximum effect is achieved in the areas pictured to the right:
- 5. When touching the assailant's body, you will not see or hear the electrical charge as you do when the unit is test fired. You can hold down the Stun Activation Button for more than 1 second, as this will not damage the unit, as it will when being test fired.
- **6.** You do not have to be concerned about the effects of the charge being transferred to you. Even if the assailant touches you while being stunned, you will not feel the effects of the charge.

EFFECTS OF THE UNIT ON AN ASSAILANT

- Touching an assailant for less than 1 second will cause minor muscle contractions and have a repelling effect.
- 2. Touching an assailant for 1 to 2 seconds will cause muscle spasms and a dazed mental state.
- 3. Touching an assailant for 3 to 5 seconds will cause loss of balance and muscle control, total mental confusion, and disorientation. All effects to the assailant are temporary; the stun gun can cause no permanent harm. (NOTE: The device should not be used for longer than 5 seconds.)

CHARGING

We recommend charging the Public Defender before it is used. With the unit powered off, simply plug the charging cord to the charging port. The Charging Light Indicator (9) will be red while charging and change to green when fully charged. Do not charge for more than 3 hours.

WARRANTY: Police Force Tactical extends a lifetime warranty against defects in materials or workmanship, with the following exceptions:

- The warranty does not cover damage resulting from accident, misuse or abuse, lack of reasonable care, moisture, the affixing of any attachment not provided with the product, loss of parts, or recharging the unit in any manner not in accordance with the included instructions.
- 2. The warranty will be voided if the unit has been opened or tampered with in any way (unless by an authorized dealer) or if any unauthorized replacement parts have been used.
- The warranty does not apply to any of the accessories including the lanyard, holster, or charging cord.

NOTICE: Purchaser must check and abide by all local laws governing the possession and use of stun guns. In addition, the stun gun must only be used in a lawful manner for self-defense. Not to be used on children, persons with heart disease, or any vital part of the human body. Not to be stored or used in environments where it is damp or humid or where there are extreme hot or cold temperatures. Do not use on metal objects.
