

Sting Ring Instructions



DIAGRAM

- 1. Contact Probes
- 2. Stun Warning Light
- 3. Squeeze-N-Stun Button
- 4. Safety Switch
- 5. Charging Port

CHARGING THE BATTERIES

- 1. The rechargeable batteries are already installed. The unit cannot be opened, as this will void the warranty.
- Before use the stun gun will need to be charged. Connect the charging cord to the charging port (5) and the other end into the USB port on your computer, your block charger for an electrical outlet or your USB car charger. There are no charging indicator lights on the unit. Simply keep it plugged in for two to three hours.
- 3. IMPORTANT: Do not charge for more than 3 hours at a time. Overcharging can damage the unit and void the warranty. Under normal use the unit will need to be recharged every 60 days. If it is used frequently or if the electrical charge produced by the stun gun becomes noticeably weaker, the unit will need to be recharged.

TESTING THE STUN GUN

(WARNING: Do not test fire the stun gun for more than 1 second as this will damage the unit and void the warranty.)

- 1. Slide the ring over your middle finger, which will position the base of the unit in the palm of your hand.
- 2. Slide the Safety Switch (4), located on the side of the unit **up** to turn off the safety. The Stun Warning Light (2) on the front of the unit will illuminate.
- 3. Close your hand tightly around the base of the unit to press the Squeeze-N-Stun Button (3) located on the bottom of the unit to test the stun gun. You will both see and hear an electrical charge fire across the top of the unit between the Contact Probes (1). When test firing the unit, do not hold the button down for more than 1 second.
- 4. When testing is complete, slide the Safety Switch (4) **down** to turn the safety back on. The Stun Warning Light (2) will turn off.

USING THIS PRODUCT IN SELF DEFENSE

- When carrying this unit, we recommend keeping it in the "ready position" (the ring over your middle finger and base in the palm of your hand).
- At the first sign of a threat, turn off the safety as described in #2 under "Testing the Stun Gun."
- If you need to use the stun gun to protect yourself, touch your assailant's body with the Contact Probes (1) and tighten your hand to press the Squeeze-N-Stun Button (3).
- 4. Touching anywhere on the assailant's body will have an effect; however, the maximum effect is achieved in the areas show to the right:
- 5. When touching the assailant's body, you will not see or hear the electrical charge as you do when the unit is test fired. You can hold down the Squeeze-N-Stun Button (3) for more than 1 second, as this will not damage the unit, as it will when being test fired.
- 6. You do not have to be concerned about the effects of the charge being transferred to you. Even if the assailant touches you while being stunned, you will not feel the effects of the charge.

EFFECTS OF THE UNIT ON AN ASSAILANT

- 1. Touching an assailant for less than 1 second will cause minor muscle contractions and have a repelling effect.
- 2. Touching an assailant for 1 to 2 seconds will cause muscle spasms and a dazed mental state.
- Touching an assailant for 3 to 5 seconds will cause loss of balance and muscle control, total mental confusion, and disorientation. All effects to the assailant are temporary; the stun gun can cause no permanent harm. (NOTE: The device should not be used for longer than 5 seconds.)

WARRANTY

Cutting Edge Products, Inc. extends a Lifetime Warranty for the product against defects in materials or workmanship, with the following exceptions:

- 1. The warranty does not cover damage resulting from accident, misuse or abuse, lack of reasonable care, moisture, the affixing of any attachment not provided with the product, loss of parts, or recharging the unit in any manner not in accordance with the included instructions.
- 2. The warranty will be voided if the unit has been opened or tampered with in any way (unless by an Authorized Dealer) or if any unauthorized replacement parts have been used.
- 3. The Lifetime Warranty covers the stun gun only. The holster and the lanyard attached to the disable pin are excluded.

TO OBTAIN SERVICE

Contact the Authorized Dealer from whom you purchased this unit for a Return Merchandise Authorization. The return unit must be sent postage prepaid and proof of purchase is required. Damage or loss occurring during shipment is not covered by this warranty.

NOTICE

Purchaser must check and abide by all local laws governing the possession and use of stun guns. In addition, the stun gun must only be used in a lawful manner for self-defense. **NOTE:** Not to be used on children, persons with heart disease, or any vital part of the human body. Not to be stored or used in environments where it is damp or humid or where there are extreme hot or cold temperatures. Do not use on metal objects.
