

# Gift card terms and conditions

Last updated: 25 March 2022

Please read the following website gift card terms and conditions (hereinafter the “Terms”) carefully before completing a gift card purchase or a purchase with gift card using the following website <https://nl.steelcase.com/> (hereinafter referred to as the « Website »).

By purchasing, accepting, or using a gift card, you agree to be bound by the Terms. These Terms are to be read in conjunction with the [Sale terms and conditions](#), [Use terms](#), [Privacy policy](#) and [Cookie policy](#).

The Website is published and maintained by Steelcase A.G. “Aktiengesellschaft” a limited company with a capital of 10.500.000 EUR, whose registered office is located at Brienner Strasse 42, 80333 Munich, Germany, registered as a company at the Munich Commercial Register under No. HRB 236047 hereinafter referred to as “Steelcase” or “we”).

## 1. GENERAL TERMS

1.1. These Terms are concluded between you and Steelcase when you purchase products on the Website using a gift card or when you purchase a gift card.

1.2. These Terms (together with any relevant documents referred to in them) set out the conditions relating to the use and redemption of our gift cards. When you purchase, receive, or apply a gift card you are accepting these Terms. Please read these Terms carefully before confirming your order.

1.3. The Terms are applicable as soon as they are put online. We may amend the Terms from time to time at our own discretion. Please look at the top of this page to see when the Terms were last updated.

1.4. These Terms, the [Sale terms and conditions](#), [Use terms](#), [Privacy policy](#) and [Cookie policy](#) constitute the entire agreement between us.

1.5. These Terms are applicable to the extent permitted by law. If any of the provisions of these Terms is deemed not valid, the other provisions herein will remain applicable and in force. If any of the provisions of these Terms is declared void or is nullified, parties will negotiate new provisions to replace such void or nullified provisions which are in line with the remaining valid provisions.

## 2. PURCHASE OF GIFT CARDS

2.1. The gift card will have a fixed predefined value (50€ / 100 € / 150€). The card is not nominative and can therefore be transferred. Please note that these Terms apply to you and to any person using the gift card. You must make the recipient aware of these Terms.

2.2. You can purchase a maximum of five (5) gift cards per basket.

2.3. The gift card will only be sent to you by email (virtually). This email will contain the unique code of the gift card, its value, limitation period and possible terms and conditions.

2.4. The gift card will be valid for a limited period of 2 years from the date of purchase. After this period, the gift card can no longer be used to make purchases.

## 3. USE OF GIFT CARDS

3.1. You can check the remaining balance of a gift card by accessing the gift card link and hovering over the code or by entering the code listed on the cart.

3.2. To use a gift card, please enter the gift card's unique code number that you received by email in the location indicated at the payment stage.

3.3. The gift card can be used on all products available on the Website, even promoted products.

3.4. You will be able to combine several gift cards together to make a purchase.

3.5. If the order total is more than the balance on your gift card, the remaining sum must be paid for by another accepted payment method or another gift card. You agree that we are not responsible if you do not have enough funds on your gift card to facilitate a transaction.

3.6. If the order total is less than the balance on your gift card, that amount will remain available on your gift card. You will be able to use it for another purchase.

3.7. If you decide to return a product (according to article 7.4 of [Sale terms and conditions](#)) originally purchased with a gift card, the initial amount of your gift card will be refunded to your original gift card, and you will be able to use again the gift card code to make a new purchase.

## 4. LIMITATIONS

4.1. The gift card is not a credit, debit, or charge card. No implied warranties attach to it.

4.2. Gift cards are not refundable or redeemable for cash or credit, unless required by law. Gift cards cannot be reloaded or used for payment outside of <https://nl.steelcase.com/>.

4.3. You cannot use a gift card to purchase other gift cards.

4.4. Gift cards may not be resold. Gift cards purchased through any unauthorized resellers or other internet websites are not guaranteed by Steelcase.

4.5. Gift cards cannot be used for unauthorized advertising, marketing, promotional or commercial purposes without our agreement. You certify and represent to Steelcase that your activities associated with our gift card will comply with these Terms and all applicable laws, rules, and regulations. You further certify and represent that you will not use our Gift cards in a misleading, deceptive, unfair, or harmful manner against Steelcase or its consumers.

4.6. You cannot amend, falsify or otherwise harm or fraud the gift card. If we become aware of such act(s), we may prevent you from using the said gift card(s).

## **5. CANCELLATION**

According to article 7.2 of [Sale terms and conditions](#), you have the right to cancel your gift card order within 14 working days of receipt provided that you have not used the gift card. Upon your request, we will check whether the gift card has been used, to determine whether you are eligible for cancellation. This right only applies to the buyer of specific gift card.

## **6. RISK OF LOSS**

6.1. The risk of loss and title for gift cards pass to you upon our electronic transmission of the gift card to you.

6.2. Gift cards must be obtained from Steelcase through the Website, and you are responsible for safeguarding your gift card from unauthorized use. We are not responsible if any gift card is lost, stolen, or destroyed, or if your gift card is used without your permission.

## **7. DISPUTES AND GOVERNING LAW**

Any dispute or claim relating in any way to gift card, will be resolved in accordance with article 11 of the [Sale terms and conditions](#).
