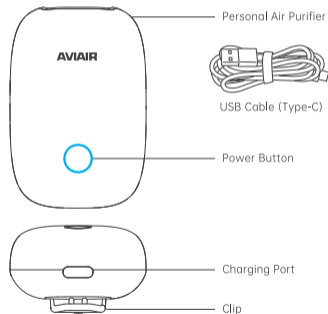

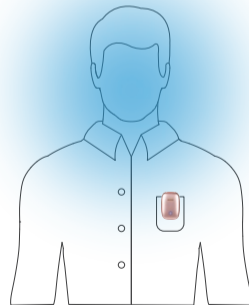


### Potential hazards during travel?

- Press the button once to turn on  (Blue breathing light)
- When battery is below 15%  (Red light)
- Charging while in use  (Red/Blue alternating light)
- Charging when turned off  (Red light)
- Charging complete while in use  (Blue breathing light)
- Charging complete in off position  (No indicator light)

## Maintenance



Recommend to use the brush to gently clean the carbon fibers once a week to allow best ion release performance.

Before cleaning, make sure the product is dry and turned off.

- **Does this product have Radiation or Ozone?**  
Our products have gone through extensive testing and validation to confirm Zero Radiation and Near Zero Ozone Output.
- **Can children wear Travo Pur MiniQ? Any restrictions on age?**  
Travo Pur MiniQ is recommended for users above 8 years old.
- **Can this product be worn on to airplanes?**  
Yes, our battery and product constructions have been designed and tested to be safe for in flight use.
- **Will I feel any electricity shock?**  
The product operates with less than 5V. From accumulation of negative ions, at times you may feel minor electrostatic. This is considered normal.
- **Is the Travo Pur MiniQ waterproof?**  
No, as any electronic product, there are electronic components inside. If product is exposed to high humidity or water, please turn off and let dry before reuse.
- **What are the two brushes on top of the unit?**  
These are carbon fibers to generate and release negative ions.
- **Why are these carbon fibers exposed, not covered up?**  
We designed this way specifically for the best result of ionic release with recessed placement to prevent damages.
- **Can I plug into any USB port to charge?**  
Yes, this product is designed to be charged using power banks, power adaptors, and computers.
