3. HAZARDS IDENTIFICATION:

Do not inhale steam and dust. If exposed in excessive quantity, it can be detrimental to health.

It is required to have a proper ventilation measures and to wear the personal protective equipment for minimizing the exposure. Do not contact with eyes and skin.

Route of Entry: Skin

Influence on Skin: Can cause minor skin irritation. If in long-term contact, it can cause blister, rash, and other skin ailments.

Influence on Eyes: Can cause moderate irritation, tearing, and reddening, but not likely to permanently injure eye tissue. If in long-term contact, it can cause sight obscurity, eye damage and loss of eyesight.

4. FIRST AID MEASURES:

If contact on eyes: Flush with plenty of water for 15 minutes, especially under eyelids. Get medical attention if irritation persists.

If ingested: Do not vomit. If the vomiting starts, lower the head under the buttocks to prevent the vomitus blocking respiratory tracts. Next, get an immediate treatment from the medical specialist.

Handling: Work under the place with fine ventilation measures and wear the protective equipment including proper respiratory protection clothes, gloves with chemical resistance, protection glasses, and protection clothes.

Storage: Store in moderately cool, well ventilated area. Isolate from direct heat, spark or flames. Avoid freezing (32F)
