#### **Product Description & Directions For Use:**

Professional-strength cleaning formula for all fine natural stone flooring. Effectively cleans marble, limestone, terrazzo, saltillo, granite, travertine, ceramic tile, brick. Helps remove oil and soils from porous stone. Safe, gentle neutral pH for sensitive natural stone. Safe to use for routine cleaning with no harsh acids or alkalis. Contains natural lemongrass, eucalyptus and tea tree oil fragrance.

Always pre-test surface to be cleaned with diluted solution in an inconspicuous area before proceeding. Do not allow cleaning solution to dry on surfaces. Avoid solution run-off to wood floors, carpets and adjacent areas. Do not mix with other cleaning products. Sweep or vacuum floors prior to cleaning to remove loose dust, dirt and surface debris. Wipe countertops with microfibre cloth. Routine cleaning: Apply solution to flooring or countertops with sprayer then wipe with flat mop or microfibre pad. Heavy soiling: Apply solution with sprayer and allow solution to stand for 10 minutes. Agitate with hand brush or floor scrubbing brush then rinse with clean water and dry floor with mop or wet pickup vacuum. Allow floors or surface to dry completely before re-use.
