

Copy of an Order-in-Council approved by His Honour the Lieutenant Governor, dated the 17th day of December, A.D. 1964.

The Committee of Council have had under consideration the report of the Honourable the Minister of Energy and Resources Management, dated the 11th day of December, 1964 wherein he states that,

WHEREAS under section 5 of The Conservation Authorities Act resolutions have been received from the City of Kingston, the Separated Town of Gananoque, the Village of Newboro and the townships of Elizabethtown, Front of Escott, Loughborough and Pittsburgh, being seven municipalities situate either wholly or partly within an area comprising the watersheds of the Cataraqui River and adjoining streams, requesting the Minister of Energy and Resources Management to call a meeting for the consideration of the establishment of a conservation authority for such watersheds;

AND WHEREAS a meeting for the consideration of the establishment of a conservation authority was called for the 30th day of November, 1964, in the Council Chambers in the City of Kingston, notice of which was sent by registered letter to the following municipalities:

and the City of Brockville and the Township of Kingston were represented by two representatives each and the City of Kingston was represented by three representatives;

AND WHEREAS a resolution was passed by a vote of twenty (20) to five (5) by the representatives present, requesting the establishment of a conservation authority for the watersheds of all the streams entering Long Reach, Hay Bay, Adolphus Reach, North Channel, Lake Ontario and the St. Lawrence River between the east boundary of the Napanee Valley Conservation Authority and the east boundary of the Township of Elizabethtown;

The Honourable the Minister of Energy and Resources Management therefore recommends that under sections 3 and 5 of The Conservation Authorities Act, a conservation authority be estab-Lished with jurisdiction over the area comprising the watersheds of all streams entering Long Reach, Hay Bay, Adolphus Reach, North Channel, Lake Ontario and the St. Lawrence River between the point where the cast boundary of the Napanee Valley Conservation Authority meets the shore of Long Reach and the point where the east boundary of the Township of Elizabethtown meets the shore of the St. Lawrence River;

And that the conservation authority be known as THE CATARAQUI REGION CONSERVATION AUTHORITY;
