Causes serious eye irritation. Toxic to aquatic life. Toxic to aquatic life with long lasting effects. PRECAUTIONARY STATEMENT: -PREVENTION-Keep away from heat/sparks/open flames/hot surfaces. No smoking. Avoid breathing mist or vapor. Wash thoroughly after handling. Contaminated work clothing should not be allowed out of the workplace. Avoid release to the environment. Wear protective gloves/eye protection/face protection.-RESPONSE-IF SWALLOWED: Immediately call a POISON CENTER/doctor. IF ON SKIN: Wash with plenty of water. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Do NOT induce vomiting. If skin irritation or rash occurs: Get medical advice/attention. If eye irritation persists: Get medical advice/attention. Take off contaminated clothing and wash it before reuse. In case of fire: Use appropriate media to extinguish. Collect spillage.-STORAGE- Store in a well-ventilated place. Keep cool. Store locked up.-DISPOSAL- Dispose of contents/container in accordance with local/regional/national/international regulations.
