Section 4: First Aid Measures

Section 5: Fire Fighting Measures

Section 6: Accidental Release Measures

Personal precautions and protective equipment and procedures: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing vapors. Small Spills: Utilize absorbent clay or sand and transfer to waste receptacles. Thoroughly clean surface areas to remove residual contamination

Cleanup Procedures: Collect all contaminated clay, media, or other cleanup materials into a waste receptacle. If cleaning surface is necessary, utilize mineral spirits or other solvents, provided adequate ventilation is available.

Section 7: Handling and Storage

Safe Handling Precautions: Do not handle until all safety precautions have been read and understood. Do not handle near an open flame or sources of ignition. Ensure adequate ventilation. Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment.

Recommendations for Storage: Store in cool area in product container away from sources of ignition or flame. **NEVER:** Store in extreme temperatures and avoid storing in direct sunlight.
