### 5. FIRE-FIGHTING MEASURES

#### 7. HANDLING AND STORAGE

**Precautions for safe handling** Take precautionary measures against static discharges when there is a risk of dust explosion. Minimize dust generation and accumulation. 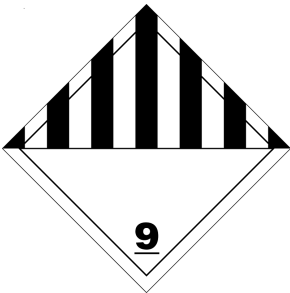
