Section 4: First Aid Measures

Section 6: Accidental Release Measures

Personal precautions, protective equipment and procedures: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Take precautionary measures against static discharges. Avoid breathing vapors. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wear appropriate personal protective equipment.
