Environmental Precautions:	 vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Prevent further leakage or spillage if safe to do so. Do not contaminate water. Avoid release to the environment. Retain and dispose of contaminated wash water. Contact local authorities in case of spillage to drain/aquatic environment.
Containment:	Absorb with clay, sand, or other non-combustible material. Prevent entry into waterways, sewers, and confined areas.
