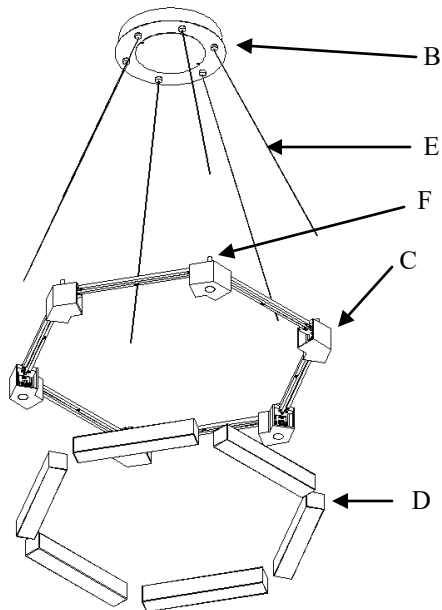

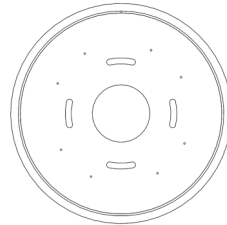

Assembly

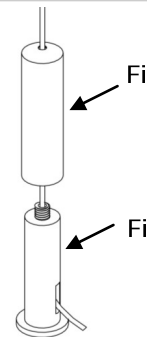
Step 1: Remove Canopy cover plate from the faceplate by removing two 4-40 flat head screws using Phillips head screw driver. Mount Canopy (B) to ceiling using the appropriate Hardware Packet (A) and included instructions.

HARDWARE PACKET Z: MOUNTS TO BUILDING



Step 2: Cables (E) and Cable Grippers (F) are marked by a numbered tag. Each Cable (E) will be inserted into the Cable Gripper (F) marked with the same number.

Step 3: After locating the corresponding Cable (E) and Cable gripper (F), unscrew the Cable Gripper Cap (Fi). Thread the Cable (E) through the Cap (Fi) and into the Gripper Body (Fii). Adjust fixture height by pushing or pulling Cable through Gripper Body while depressing threaded plunger at top of Gripper.



CAUTION: CABLES ARE CONDUCTIVE. DO NOT POWER FIXTURE WHILE CABLES ARE IN CONTACT WITH ANY CONDUCTIVE SURFACE. THIS INCLUDES HAVING THE CABLE PROTRUDE THROUGH THE GRIPPER AND TOUCH THE BODY OF THE LIGHT FIXTURE.

Step 4: Use a measuring tape and level to ensure the fixture is hanging at the desired distance from the Canopy. When desired height is attained cut excess Cable flush with Gripper Body. Thread Cable Gripper Cap back onto Body.

Step 5: Make Electrical Connections from the building to the Drivers inside of Canopy using the wire nuts provided. Replace Cover plate.

Glass Install Instructions

CAUTION: INSTALL GLASS IN ORDER SHOWN, TO HELP KEEP FIXTURE BALANCED SO GLASS DOES NOT FALL OUT DURING INSTALLATION.

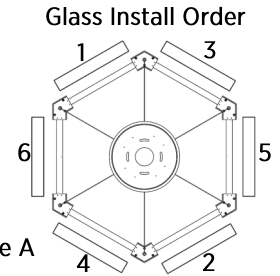
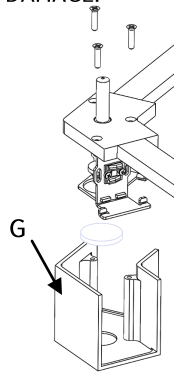

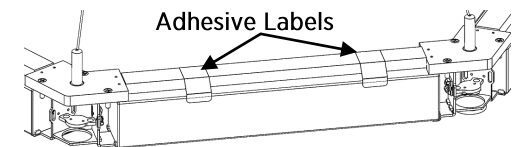

Step 6: Using Phillips head screw driver, remove the six (6) corner shrouds (G) from hanging body assembly. Set aside. Note: Three (3) of the corners have downlights and acrylic diffusers, while the

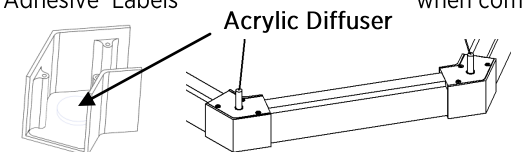


Step 7: Locate Axis Glass (D) and orient so the seam is position on the top and bottom. This is how the glass will be installed on the fixture.

Step 8: Install Axis Glass one piece at a time, following the Glass Install Order shown above in Figure A. Install by sliding glass into place from the side as shown. Center the glass and apply two (2) Adhesive Labels (H) to



Step 9: Install Acrylic Diffuser into three shrouds with downlight holes. Install Shrouds to Body from the bottom, using same screws that were removed in Step 6. Take care to install Downlight Corner Shrouds on the three corners wired with Downlight LEDs. Take care that Acrylic Diffuser is seated properly during and after shroud installation. Remove Adhesive Labels when com-

ONE YEAR LIMITED WARRANTY

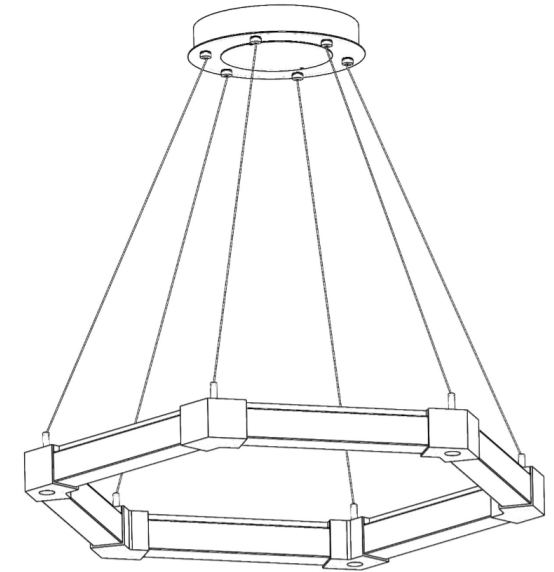
