The 2021/2022 data includes a more limited record of Scope 3 emissions. Business travel was curtailed during 2021 due to Covid restrictions and guidelines. Employee commuting data has not currently been recorded for inclusion. Waste generated is included from mid-2021 when data from our supplier was recorded. Upstream / downstream transportation and distribution data has not been quantified as yet, we aim to measure this in the future. The data reported is for UK emissions only.


Emissions Reduction Targets

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 45.9 tCO₂e, a 10.8% reduction against the 2022 baseline.

The measures will be in effect when performing the contract.

- Eliminating the use of coloured dyes in Saphena AES
- Adoption of LED lighting throughout our workplace
- Installation of Solar PV panels on our warehouse roofing
- Installation of electric car charging ports and plan to move all company vehicles to electric, this is aimed to be completed by 2028
- · Reusing or recycling of cardboard packaging, where possible
- Encouraging virtual meetings to reduce business travel, where appropriate.

In the future we hope to implement further measures such as:

- Elimination of all single use plastic from product packaging by 2028
- More sustainable yarns for use in the manufacturing of our hosiery products
- Investing in CHP (Combined Heat and Power plant) to reduce energy consumption
- Implementation of an ISO 14001 Environmental Management System.
