#### **PREPARATION**

Protect people, property, vehicles, and all non masonry surfaces that may come into contact with the product, spray, wind drift or fumes. Avoid exposing passersby and building occupants to product and mists.

The surface must be clean, dry and absorbent. Remove mud, efflorescence and hard water staining with Enviro Klean® Safety Klean. Remove general soiling, food-related stains, mold and mildew with Stand Off® All Surface Cleaner. Contact PROSOCO for additional cleaning recommendations as needed, toll-free at 800-255-4255. Do not use raw acids.

Let cleaned surfaces dry completely. Let freshly placed concrete, mortar, caulking or sealant compounds cure before applying Color Enhancer WB.

#### **Surface and Air Temperatures**

Surface and air temperatures must be  $40^{\circ}F$  ( $4^{\circ}C$ ) and rising. Do not apply when air temperatures exceed  $90^{\circ}F$  ( $32^{\circ}C$ ).

#### **Equipment**

Apply with brush, roller or low-pressure spray (<50 psi). Fan tips are recommended for sprayers. Do not atomize.

#### **Storage and Handling**

Store in a cool, dry place. Always seal container after dispensing. Do not alter or mix with other chemicals. Published shelf life assumes upright

storage of factory sealed container in a dry place. Maintain temperatures of 40–100°F (4–38°C). Keep from freezing. Do not double stack pallets. Dispose of unused product and container in accordance with local, state and federal regulations.

#### **APPLICATION**

Before use, read "Preparation" and "Safety Information."

**ALWAYS TEST** each type of surface for suitability and results before overall application. Test using the following application instructions. Let test dry thoroughly before inspection.

#### **Dilution**

Apply as packaged. Do not dilute or alter, or use for purposes other than specified. Mix well before applying.

#### **Coverage Rates**

Coverage rates vary based on surface texture and porosity. Always test.

- Porous, textured surfaces:
   60–100 sq.ft./gal (6–9 sq.m.)
- Semi-porous surfaces: 100—150 sq.ft./gal (9—14 sq.m.)
- Dense, smooth surfaces: 150–300 sq.ft./gal (14–30 sq.m.)

#### **ALWAYS TEST**

ALWAYS TEST a small area of each surface to confirm suitability and desired results before starting overall application. Test with the same equipment, recommended surface preparation and application procedures planned for general application.

#### **Application Instructions**

- Apply to a clean dry surface using a brush, roller or low pressure sprayer. Apply enough material to keep the surface uniformly wet for 2—3 minutes before penetration.
- 2. Broom out puddles. Collect excess that does not penetrate with an absorbent towel.
- 3. Some surfaces need a second application to get the desired color enhancement. Let the surface dry 2—3 hours between coats.

#### **Drying Time**

Protect treated surfaces from foot traffic for at least 6 hours. Protect from vehicular traffic and rainfall for 24 hours. Allow 3 days for Color Enhancer WB to gain its water-repellency properties.

#### Cleanup

Clean tools, equipment, and over spray with soap and warm water.
