



INSTRUCTIONS:

STEP 1: CLARIFY

- Wet the hair and liberally apply KHS Aftercare Salt Free Shampoo and gently massage into hair and scalp from roots to tips.
- Rinse thoroughly.
- RE-Apply Shampoo and gently massage into hair and scalp from roots to tips (REPEAT STEP 1)
- Rinse thoroughly.

STEP 2: CONDITION

- Apply KHS Aftercare Salt Free Conditioner to wet hair.
- Gently massage into hair and leave for 10 minutes
- Rinse thoroughly
- Dry and style as desired.

ADVICE / RECOMMENDATIONS:

- To ensure best results and extend the life of any KHS System/Treatment, it is recommended that you use KHS Salt Free Shampoo & Conditioner daily.
- We recommend waiting 10-14 Days in between the use of additional KHS System/Treatments.
- Do not use 10 days before or after a colour service.
- For best results additional Straightening with Flat Iron/ Hair Straighteners may be required.

! Never keep any unused mixture and dispose of immediately to avoid the bottle bursting and resulting damage from the product overflowing.

A SAFETY INSTRUCTIONS: READ BEFORE USAGE

THIS PRODUCT IS NOT INTENDED FOR USE ON PERSONS UNDER THE AGE OF 16. IT IS ESSENTIAL THAT YOU ALWAYS PERFORM A SKIN ALLERGY TEST 48 HOURS BEFORE EACH USE OF THIS PRODUCT AS AN ALLERGY CAN DEVELOP SUDDENLY, EVEN THOUGH YOU HAVE PREVIOUSLY USED A HAIR STRAIGHTENING PRODUCT OF THIS OR ANY OTHER BRAND.

IMPORTANT: KERATIN HAIR SYSTEMS IN RARE CASES CAN CAUSE AN ALLERGIC REACTION WHICH IN CERTAIN CASES MAY BE SEVERE. THEREFORE TO HELP REDUCE THE RISK OF AN ALLERGIC REACTION, IT IS ESSENTIAL TO FOLLOW THE PRECAUTIONS BELOW:

- Temporary "black henna" tattoos may increase your risk of allergy.
- **Do not use this product on your hair if:**
 - You have a rash on your face or sensitive, irritated and damaged scalp.
 - You have ever experienced any reaction after colouring/ straightening your hair.
 - You have experienced a reaction to a temporary "black henna" tattoo in the past.

HOW TO PERFORM THE SKIN ALLERGY TEST:

- Remove earrings. Behind the ear and using a cotton-bud, apply a small quantity of product, sufficient cover an area of 1 to 2 cm (e.g. the SIZE of a small coin). RE-apply allowing it to dry between applications.
- Carefully reseal the product container and keep it for the applications 48hrs later.
- Leave for 48 hours without washing, covering or touching. If during this period you notice any abnormal reactions, such as itching, redness or swelling in or around the test area, **DO NOT APPLY THE PRODUCT.**

SPECIAL PRECAUTIONS:

- **IN CASE OF A REACTION DURING THE APPLICATION** such as intense stinging, irritation, rash or burning sensation on the scalp, rinse immediately and discontinue use. If you experience shortness of breath, seek immediate medical attention.
- Before straightening your hair again, consult a doctor.
- **IF DURING THE DAYS FOLLOWING APPLICATION**, itching, redness or spots on the scalp or skin occurs, swelling of the eyes and/or face, blisters or oozing of the scalp and/ or skin occurs, it is recommended that you consult a doctor.
- Keep out of reach of children.
- Avoid contact of the product with skin and eyes. Do not use to eye eyelashes or eyebrows.
- Rinse eyes immediately and thoroughly if product comes into contact with them. If you wear contact lenses, take them out before rinsing your eyes thoroughly with water.
- Wear the gloves supplied in the carton.
- Rinse hair well after application.
- Prepare and apply the mixture in a well-ventilated area.
- Do not inhale or ingest.
- For all questions concerning your individual sensitivity, consult your doctor.
- Do not use on beard or moustache or for any other purpose than straightening your hair. Avoid any unnecessary contact with the skin.
- Wait at least 2 weeks after using a relaxer, a perm, colouring or a Straightening process on the hair before applying this product.
- Do not use if your hair has been coloured with henna or with a progressive hair colorant.
