WHO'S ELIGIBLE FOR THE ARHAUS TRADE PROGRAM?

The Arhaus Trade Program is open to professionals in the design and real estate industries in the United States, U.S. territories, Mexico, and Canada.

HOW DO I APPLY?

Visit www.Arhaus.com/pages/trade-services to apply. Once your application is submitted, you'll receive an email with your Trade ID number and instructions for uploading your W-9 or W-8. You will need to submit the appropriate tax form to receive commissions. Your Trade Account will be active once your fully completed and signed W-9 or W-8 is processed.

HOW DO I PLACE TRADE ORDERS AND EARN COMMISSIONS?

- Provide your Trade ID number at checkout to earn commissions on in-store purchases.
- An Online Trade Specialist will need to process Arhaus.com orders to ensure that you
 receive commissions. To place an online order, simply email TradeSales@Arhaus.com
 with your order and Trade ID number, or call 866-427-4287 and select option 5 to
 speak with a Trade Specialist.
- If a client plans to make a store purchase and you will not be with them, please notify
 the store team in advance, or immediately after their purchase, so we can ensure you
 receive credit for it.
- Arhaus Loft and clearance center orders are not eligible for commissions.

HOW DO I RECEIVE TAX EXEMPTIONS?

To qualify for tax exemptions, you'll need to submit a copy of your tax exemption certificate for each state where merchandise will be delivered. You must present this certificate with each order at the time of purchase, in-store or online, to have taxes removed. If the billing information on the order does not match the information on the certificate, your purchase will not be eligible for a tax exemption.
