



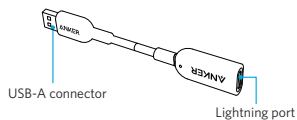

1. Plug the Lightning connector of the Apple earpods into the Lightning port of the cable.

ES: Conecte el conector de alimentación de los auriculares de Apple a la toma de alimentación del cable.

FR: Branchez le connecteur Lightning des Apple EarPods au port Lightning du câble.

JP: AppleイヤホンのLightning端子を、ケーブルのLightningポートに差し込みます。

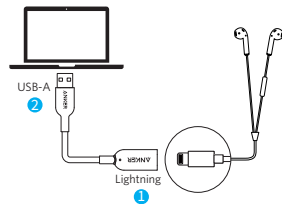
2. Plug the other end into a USB-A port on a MacBook.

ES: Conecte el otro extremo en un puerto USB-A de su Macbook.

FR: Branchez l'autre extrémité dans le port USB-A du MacBook.

JP: ケーブルのもう一方の端子を、MacBookのUSB-Aポートに差し込みます。

CN: 将另一端插入 MacBook 的 USB-A 端口。

3. Go to MacBook's System Preference Settings and click the sound icon. The A8197 cable will be automatically detected as "Lightning Adapter" on the input and output settings page.

ES: Vaya a los Ajustes de preferencias del sistema del MacBook y Haga Click en el icono de sonido. El cable A8197 se detectará automáticamente como "Adaptador de alimentación" en la página de ajustes de entrada y de salida.

FR: Accédez aux réglages dans Préférences Système du MacBook et cliquez sur l'icône Son. Le câble A8197 sera automatiquement détecté en tant qu'« Adaptateur Lightning » sur la page des réglages d'entrée et de sortie.

4. Select "Lightning Adapter" on the input or output page to complete Lightning earpods setting.

▶ You should now hear audio output from the MacBook.
