





SAFETY PRECAUTIONS


WARNING: CHOKING HAZARD – Small parts. This product contains small parts and is not suitable for children under 3 years old.

- Remove all packaging before using this device. Please keep all packaging materials out of reach of children and pets.
- Properly dispose of all packing materials immediately after unpacking product, as the bags used for packaging could present a suffocation or choking hazard.
- Read all instructions carefully before attempting to operate this device. Improper usage could result in injury or a reduction in efficacy.
- Make sure the hitch installed on your vehicle is rated to support up to 550 lbs. (249.5 kg.)
- When traveling with the carrier secured to a vehicle, do not exceed a speed of 80 mi/hr. (130 km/hr)
- Always check that the cargo is secure before beginning a trip.
- Make sure all the bolts and nuts are in good condition and do not appear rusted or worn out. Using worn parts can result in the rack not supporting the cargo properly.
- Be sure to research and follow all national and local regulations regarding carrying cargo on a vehicle.
- Do not exceed the rack's maximum capacity of 500 lbs. (226.8 kg.)
- Before beginning a trip, we recommend taking a test drive in a safe area to ensure the cargo is completely secure.
- Do not let children play on or around the rack as this can cause accidents, injuries, or damage the rack.






ASSEMBLY INSTRUCTIONS


1. Attach the **(B)** Arm to **(A)** Halves of Platform with **(H)** M10 x 70 Bolt Set.




2.Assemble the Platform by attaching the ($\bf C$) Connection Plates with ($\bf J$) M8 x 16 Carriage Bolt Sets.




3.Connect the (**D**) Hitch Tube to the Platform by using (**I**) M12 x 75 Bolt Set and (**E**) 12mm Pin and Clip Set.



4. Mount the Assembled Carrier to your vehicle's hitch receiver by using (**F**) 16mm Pin and Clip Set.



5. Adhere (${f G}$) Waterproof Reflective Stickers to the Platform.
