

HL50 Lamella Tank

50m2 Settling Area Lamella Tank

The HL50 is designed to effectively recover suspended solid particles from water in continuous pumping applications.

HL is a simple but effective way of ensuring that environmental pollution concerns of high suspended solids in water, from activity such as groundwork dewatering and silt laden wash water are safely met. This ensures compliance with authorities such as the Environment Agency and Water board's site water standards requirements.

These tanks are typically used with 4" pumps, though this can vary depending on the appropriate flow rate required. Where there are greater treatment volume requirements, multiple units can be easily connected in parallel to increase settlement capacity.

How it Works

Silt laden contaminated water is fed into the unit in the back chamber, where it flows around into the base of the lamella plate section of the tank. The water stream flows upward between the inclined Lamella plates.

With the reduced flow, the solids fall to the plate surface, where they slide by gravity, down the plate, to the sludge collection chamber at the bottom. The sludge is then periodically drained down using the valve at the bottom of the hopper.

The HL50 effective settlement area is 50m2, giving it a typical treatment flowrate of 25m3/H. The HL50 can be used in combination with coagulants and flocculants to remove superfine particles, heavy metals, and more.






