Merchandise is accepted on a fifty-fifty (50%-50%) split of the selling price of the item.

This Contract with French Courtyard is for one hundred twenty (120) days. If the merchandise has not sold within that period it is the Consignor's responsibility to pick up the merchandise or it will be donated. **The French Courtyard does not contact the Consignor at the end of the period.** _____ (Consignor's initials)

All furniture is for the contract term of one hundred twenty (120). French Courtyard may reduce merchandise up to twenty (20%) percent of the original asking price during the first thirty (30) days for any store promotion or sale. After thirty (30) days, merchandise will be reduced twenty (20%) percent in price from the original asking price. After sixty (60) days, merchandise will be reduced thirty (30%) percent in price from the original asking price. After ninety (90) days, merchandise will be reduced fifty (50%) percent in price from the original asking price. At one hundred twenty (120) days the contract will expire. **Consignors receive access to their online account to track consignments. French Courtyard does not notify Consignors when their items have sold or expired. Payouts will not be made for the sale of expired inventory.** _____ (Consignor's initials)

A five (5%) percent Buyer's Fee will be added to all sales.

Furniture will be photographed, added to the store website, and then placed on the showroom floor as space becomes available. Not all furniture will be placed on the sale floor. _____ (Consignor's initials)

All consigned artwork, accessories, mirrors and lamps, will only be for a sixty (60) day contract. After thirty (30) days, items will be marked down fifty (50%) percent and after sixty (60) days, Consignor is responsible for picking up any items that have not sold or the store will donate the items. **French Courtyard does not notify Consignors when their items have sold or expired. Payouts will not be made for the sale of expired inventory.** _____ (Consignor's initials)

Consignors are paid on the fifteenth (15th) day of the month after the month of sale. **Checks are to be picked up at the store.** Checks are only held in the store for three (3) months after being printed. If the check is not picked up by the consignor within three (3) months of being printed, all funds are forfeited and checks are voided. When items sell, the store does not contact the Consignor. It is the sole responsibility of the Consignor to call regarding the sale of their items. _____ (Consignor's initials)

French Courtyard is not responsible for any loss or damage to articles caused by handling. It is the responsibility of the owner to carry their own insurance for consigned items. At the end of the one hundred twenty (120) day contract all items left on my inventory will become the property of the French Courtyard. _____ (Consignor's initials)
