## LuxPower LXP6000EXP Inverter Warranty Document

## **LuxPower Inverter Warranty Terms and Conditions**

- **1. Warranty Coverage:** LuxPowerTeck provides a base warranty of 2 years for the LXP6K LuxPower inverter ("the Unit"). This warranty covers defects in materials and workmanship, providing peace of mind for the initial period of ownership.
- **2. Extended Warranty through Maple Leaf Power Systems Distributors:** For customers who purchase the LXP6K LuxPower inverter through an approved Maple Leaf Power Systems Distributor, an extended warranty of up to 5 years is offered. This extended warranty is inclusive of the base 2-year warranty provided by LuxPowerTeck, resulting in a total coverage period of 5 years from the date of purchase.
- **3. Conditions for Extended Warranty:** To qualify for the extended 5-year warranty, the Unit must be purchased through an approved Maple Leaf Power Systems Distributor. Customers are required to retain the original purchase invoice as proof of purchase. The extended warranty is applicable only to the original purchaser and is non-transferable.
- **4. Warranty Service Location:** In the event of a warranty claim, LuxPowerTeck and Maple Leaf Power Systems will facilitate repair and support services through the MLP Canadian warehouse located in Barrie, Canada. Customers are responsible for shipping the defective Unit to the designated warehouse, and Maple Leaf Power Systems will cover the cost of return shipping for the repaired or replaced Unit.
- **5. Warranty Exclusions:** This warranty does not cover damages or defects caused by:
  - Improper installation, operation, or maintenance of the Unit.
  - Unauthorized modifications or repairs.
  - Acts of nature, accidents, or external forces.
  - Use of the Unit for purposes other than its intended application.
- **6. Warranty Claim Process:** To initiate a warranty claim, customers must contact the Maple Leaf Power Systems Distributor through which the Unit was purchased. The distributor will guide customers through the necessary steps for validation and facilitate the shipment of the Unit to the MLP Canadian warehouse for repair or replacement.

- **7. Limitation of Liability:** LuxPowerTeck's liability under this warranty is limited to the repair or replacement of the defective unit within the initial 2-year manufacturer offered warranty. MLP will cover will cover the additional 3 years under the terms and conditions of this "inverter Warranty Document". LuxPowerTeck and MLP shall not be liable for any indirect, consequential, or incidental damages arising from the use or inability to use the Unit.
- **8. Governing Law:** This warranty is governed by the laws of the province of Ontario, Canada.
