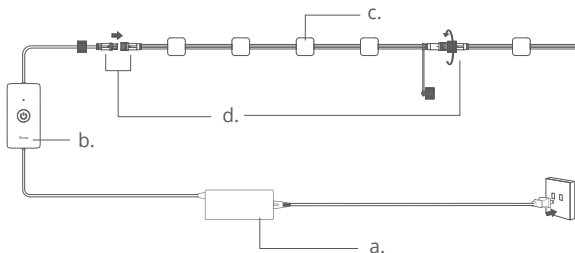

Use the clips to secure the strip lights firmly during installation.
- 2 Cannot connect to Bluetooth.
  - a. Do not skip the Bluetooth connection in the app.
  - b. Ensure the Bluetooth on your smartphone has been turned on.
  - c. Your smartphone may be incompatible with Govee Home app. Try using a different smartphone then reconnect.
  - d. Power the light and your smartphone's Bluetooth off then on, then try again.
  - e. Ensure that your smartphone is within 1m/3.28ft of the light when connecting.
  - f. Clear any obstructions that are between the light and your smartphone.
- 3 The light does not display the selected color fully/Some LED beads do not light up.

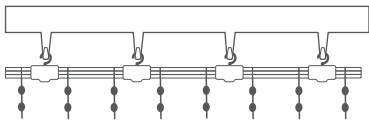
## Installing Your Device

### Method 1: Use G4 Hooks

1. Install the G4 hooks between the two wires.



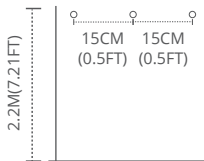
2. Hang the curtain lights with G4 hooks onto the curtain hooks.



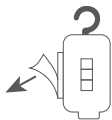
3. Connect to the adapter and plug into power to test the device.

### Method 2: Use G4 Hooks and VHB Gums

1. Clean the surface before installation.
2. Make marks on the surface that are higher than 7.21ft/2.2m with intervals of 0.5ft/15cm. Keep all the marks on the same level.

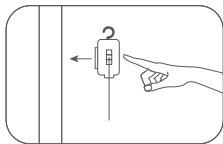


3. Stick the provided VHB gums to the back of the G4 hooks.



4. Stick the G4 hooks to where the marks were made on the surface.

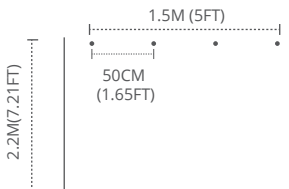
Note: Press the G4 hooks more than 10 seconds.



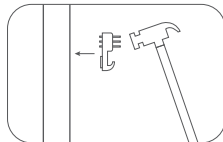
5. Connect to the adapter and plug into power to test the device.

### Method 3: Use Seamless Nails

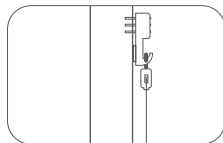
1. Clean the surface before installation.
2. Make 4 marks on the surface that are higher than 7.21ft/2.2m with intervals of 1.65ft/50cm. Keep the 4 marks on the same level.



3. Fix the provided seamless nails to where the marks were made on the surface.



4. Hang the curtain lights on the fixed nails. (Please prepare a string that is longer than 4.9ft/1.5m to fix on the seamless nails).
