New Standards, New Concepts, New Patterns-The Symposium on Consistency Evaluation of Chinese Medicine Extract Granules and National Standard Application was successfully held



On September 25, the "2021 Working Conference of the Hospital Pharmacy Branch of the Chinese Society of Chinese Medicine and the Symposium on the Consistency Evaluation of Chinese Medicine Formula Granules and the Application of National Standards" was successfully held in Beijing. The conference was co-hosted by the Hospital Pharmacy Branch of the Chinese Society of Chinese Medicine and Beijing Pharmaceutical Association, and co-organized by Jiangyin Tianjiang Pharmaceutical Co., Ltd. This conference brought together more than 20 pharmacy and clinical experts from Chinese medicine hospitals and general hospitals from all provinces and municipalities across the country. This meeting took the form of a combination of online and offline, and discussed key issues such as the consistency evaluation of formula particles and the implementation of national standards.

According to Hu Qifei, general manager of Jiangyin Tianjiang Pharmaceutical Co., Ltd., Tianjiang Pharmaceutical, based on its own perfect scientific research system, promotes industry societies to carry out the evaluation project of consistency between classic decoctions and formula granules, and devotes itself to the formulation of national standards. On September 5, 2021, the online international academic seminar "Research and New Progress in Infertility in Traditional Chinese Medicine" was successfully held. This academic forum was organized by the Australian National Federation of Chinese Medicine and Acupuncture Societies, undertook by the Australian National Federation of Chinese Medicine and Acupuncture Societies Victoria Branch (FCMA-VIC), and co-organized by Jiangyin Tianjiang Pharmaceutical Co., Ltd.

The conference was opened by Lin Ziqiang, chairman of the Australian National Federation of Chinese Medicine and Acupuncture Societies, and 11 domestic and foreign infertility Chinese medicine experts were invited to give online lectures. The online academic exchanges lasted 12 hours in total. Experts focused on issues related to infertility in terms of clinical, treatment, prescription and medication. Simultaneous translation in Chinese and English was used in this academic exchange, and the attending Chinese medicine practitioners said that they have benefited a lot. After the meeting, the participants remained enthusiastic, interacting with experts in the exchange group, and watched the replay of the meeting repeatedly.

The first meeting of the International Forum on New Crown Vaccine Cooperation was held! Chinese vaccine companies make a promise!



On the evening of August 5, the first meeting of the International Forum on New Coronary Vaccine Cooperation was held by video. Representatives of various countries, representatives of the United Nations, international organizations, and representatives of related enterprises conducted in-depth discussions on the theme of "strengthening international cooperation in vaccines and advancing the fair and reasonable distribution of global vaccines". The meeting reached a five-point consensus, and 23 participating countries also jointly issued a joint statement on the International Forum on New Coronary Vaccine Cooperation.

Liu Jingzhen, Chairman of Sinopharm Group, spoke at the forum on behalf of Chinese vaccine companies. Companies from various countries have agreed to establish partnerships to expand vaccine production and supply; to reach a cooperation intention of more than 1.5 billion doses of vaccines in 2021, and Chinese companies will provide partners in the form of finished products or original solutions. On September 26, the second China-Africa Economic and Trade Expo opened in Changsha, Hunan. In the "China's Anti-epidemic Assistance" section of the "China-Africa Economic and Trade Cooperation Achievements Exhibition", the organizing committee introduced the results of China's Sinopharm's vaccine assistance to Africa.

The State Food and Drug Administration approved, promulgated and publicized the National Drug Standards for Chinese Medicine Formula Granules

The State Food and Drug Administration approved, promulgated and publicized the National Drug Standards for Chinese Medicine Formula Granules Approved by the National Medical Products Administration, the first batch of 160 Chinese medicine formula granules national drug standards have been officially promulgated and will be officially implemented on November 1, 2021. In addition, the second batch of 36 Chinese medicine formula granules national drug standards are being announced. The first two batches of national formula granule standards total 196, of which 48 product standards declared by Jiangyin Tianjiang Pharmaceutical Co., Ltd. have been approved.

The overall situation of the national standard:

- On August 5, 2016, National Pharmacopoeia Commission "Technical Requirements for Quality Control and Standard Establishment of Chinese Medicine Formula Granules (Soliciting Opinions)"
- On April 11, 2018, the first national standard review meeting of the National Pharmacopoeia Commission
- On November 8, 19, the State Food and Drug Administration "Technical Requirements for Quality Control and Standard Establishment of Chinese Medicine Formula Granules (Soliciting Opinions)"
- On November 8, 19, the first batch of 160 varieties of Chinese medicine formula granules national standards was announced by the Pharmacopoeia Commission
- On February 10, 21, the State Food and Drug Administration "Technical Requirements for Quality Control and Standard Establishment of Chinese Medicine Formula Granules", "Announcement on Ending the Pilot Work of Chinese Medicine Formula Granules"
- On April 29, 2021, the first batch of 160 varieties of Chinese medicine formula granules national standards was officially released
- On April 30, 2021, the second batch of 36 varieties of Chinese medicine formula granules national standards publicized by the Pharmacopoeia Commission
- On August 27, 2021, "Announcement on the Acceptance and Evaluation of National Standard Application Materials for Chinese Medicine Formula Granules (Phase 1, 2021)"

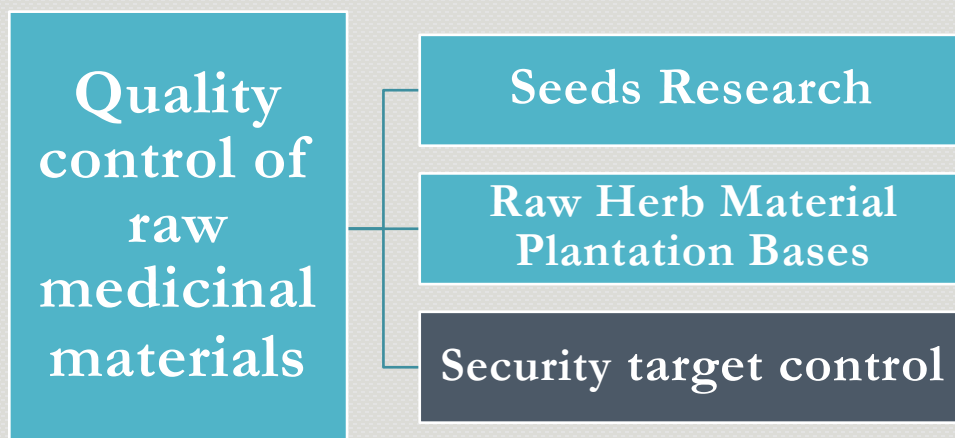
Chinese medicine extract granules, using standardized processed Chinese medicine pieces as raw materials, are made with modern pharmaceutical technology such as scientific extraction, low-temperature concentration, instantaneous drying technology, etc., under the guidance of Chinese medicine theory,

In order to ensure the stability, uniformity and effectiveness of the product quality of traditional Chinese medicine formula granules, Tianjiang Pharmaceutical Co., Ltd. carries out quality control throughout the whole process from the source of the medicinal materials to the final product, including:

- (1) Quality control of medicinal materials
- (2) Quality control of decoction pieces
- (3) Quality control of preparation process
- (4) Production monitoring
- (5) Finished product quality control
- (6) Enterprise quality traceability system
- (7) Quality standards

"Tianjiang Newsletter" will continue to transmit Tianjiang quality control information. In this issue, we will share the first step of quality control -- quality control of medicinal materials

Quality control of raw medicinal materials



Aiming at the endogenous factors that affect the safety of traditional Chinese medicine, the company has strengthened the research on the basis, processing and production technology to ensure its safety and effectiveness. For the raw materials and finished products of traditional Chinese medicine formula granules, inductively coupled plasma mass spectrometry technology is used to detect the limit of heavy metals and harmful elements, and technical methods such as gas chromatography and high performance liquid chromatography are used to detect pesticide residues, sulfur dioxide residues, and aflatoxin Detection.

After a general survey of multiple batches of samples of all varieties, more than 100 varieties that need to be monitored for heavy metals and harmful elements, pesticide residues, sulfur dioxide and aflatoxin were screened out, and they were listed as key research and monitoring varieties, and targeted research was carried out. Investigate, study the reasons for its occurrence, explore effective prevention and control methods and measures, and establish internal control standards for the safety of key varieties from raw materials to finished products based on this. This work fills the gap in the research on quality standards related to the safety indicators of Chinese medicine formula granules in China.

Security target control

Heavy metal limits control

- ◆ Optimizing the origin of raw medicinal materials, and determining the safe origin of raw medicinal materials through the inspection of the soil, water quality, and air environment of the place of production and the detection and comparison of collected samples.
- ◆ To study the accumulation characteristics of heavy metals in different medicinal materials and the accumulation characteristics of heavy metals in different parts of plants (animals), to guide the selection of base planting varieties and the evaluation of medicinal parts.
- ◆ Include heavy metals in routine inspection items, refer to the limit standards for heavy metals in various countries, establish internal control standards that meet international requirements, and implement internal control of raw materials and routine inspections of finished products.

Pesticide residue control

- ◆ Choose a suitable location, establish a medicinal material production base or a cooperative production base, and control the use of pesticides by strengthening field management.
- ◆ Develop internal control standards for pesticide residues, and conduct pesticide residue testing before production. Any unqualified product must be re-assessed for the origin of the variety.

Security target control

Aflatoxin control

- ◆ Build a medicinal material production base or cooperation base, and formulate standard operating procedures for processing at the origin. For example, when jujube kernels are removed from the production area, the method of long-term soaking and pounding to remove the pulp is generally used. During this period, it is easy to breed mold, causing aflatoxin to exceed the standard. After finding the source, the company established a cooperative base, requiring processing in strict accordance with the provided standard operating procedures, such as harvesting mature fruits and peeling meat by hand.
- ◆ For the varieties that are not easy to preserve, arrange the production of new materials according to the season. For example, *Corydalis yanhusuo* is often moldy due to untimely drying during processing. In response to this, the company requires the suppliers of the cooperative base to arrange for drying immediately after cooking when the suppliers of the cooperative base produce new processing, and the company arranges the production of materials in a timely manner.

Sulfur fumigation

- ◆ Sulfur fumigation is one of the common methods of traditional Chinese medicinal materials to prevent mildew and insects. Therefore, excessive sulfur in medicinal materials sometimes occurs. According to the results of Tianjiang Pharmaceutical's general survey, more than 60 varieties of sulfur dioxide that easily exceed the standard are considered as key monitoring. With reference to international sulfur dioxide detection methods and standards, strict internal control standards have been established.

TCM treatment of polycystic ovary syndrome

Polycystic ovary syndrome is one of the common gynecological endocrine diseases in clinic. In recent years, its incidence has been on the rise, and its cause has not yet been fully elucidated. Current research believes that it may be due to the interaction of certain genetic genes and environmental factors. Tianjiang Pharmaceutical invited Yang Sheng, director of the Department of Gynecology, Fuzhou Hospital of Traditional Chinese Medicine, to give us a lecture on "Polycystic Ovarian Syndrome Treatment in Traditional Chinese Medicine".



Sheng YANG:

Graduated from the Medical Department of Fujian University of Traditional Chinese Medicine. Engaged in the diagnosis and treatment, scientific research, and teaching of Chinese medicine in gynecology for more than 30 years. He was taught by Professor Luo Yuankai, the sacred hand of Lingnan Gynecology, and Professor Sun Tancun, the sixth generation descendant of Sun's Gynecology.

Areas of expertise: Gynecological menstrual diseases (menorrhagia, oligomenorrhea, early and late menstruation), dysmenorrhea, amenorrhea, threatened abortion, pregnancy disease, postpartum disease, infertility, menopausal syndrome, gynecological inflammation, obesity, facial acne, chloasma Spot and so on.

The immunological pathogenesis of vitiligo

Vitiligo is a relatively common skin disease. Most of these diseases are caused by the loss of skin melanocyte function. The specific cause is not yet clear. Vitiligo is relatively harmful and will have a huge impact on the patient's personal image and psychology. In this issue, Tianjiang Pharmaceutical invited Yang Ji, director of Zhongshan Hospital Affiliated to Fudan University, to give us a lecture on the immunological pathogenesis of vitiligo, introducing the current research progress on the immunological pathogenesis of vitiligo.

TCM treatment of melasma

Melasma is a chronic, acquired skin disease with increased facial pigmentation. The lesions are yellowish-brown or dark brown patches, often symmetrically distributed on the cheeks, and can also involve the periorbital, forehead, upper lip and nose, and the edges are generally more obvious.

There are no subjective symptoms and general discomfort. The depth of the spots is related to the season, sun exposure, and endocrine factors. The incidence rate of Asian women of childbearing age is as high as 30%, and it is easy to relapse and difficult to cure. At present, TCM treatment has unique advantages in clinical practice. Tianjiang Pharmaceutical has specially invited Professor Min Zhongsheng, the chief physician of Jiangsu Provincial Hospital of Traditional Chinese Medicine, to share with you the "Traditional Chinese Medicine Treatment of Chloasma" based on his many years of clinical experience. TCM diagnosis and treatment of peptic ulcer

Peptic ulcer mainly refers to chronic ulcers that occur in the stomach and duodenum. It is a frequently-occurring and common disease. There are various factors in the formation of ulcers. Among them, the digestive effect of acidic gastric juice on the mucosa is the basic factor in the formation of ulcers, hence the name. Tianjiang Pharmaceutical specially invited Liu Zhuhua, director of the Affiliated Hospital of Shanxi University of Traditional Chinese Medicine to teach us "Diagnosis and Treatment of Peptic Ulcer in Traditional Chinese Medicine".

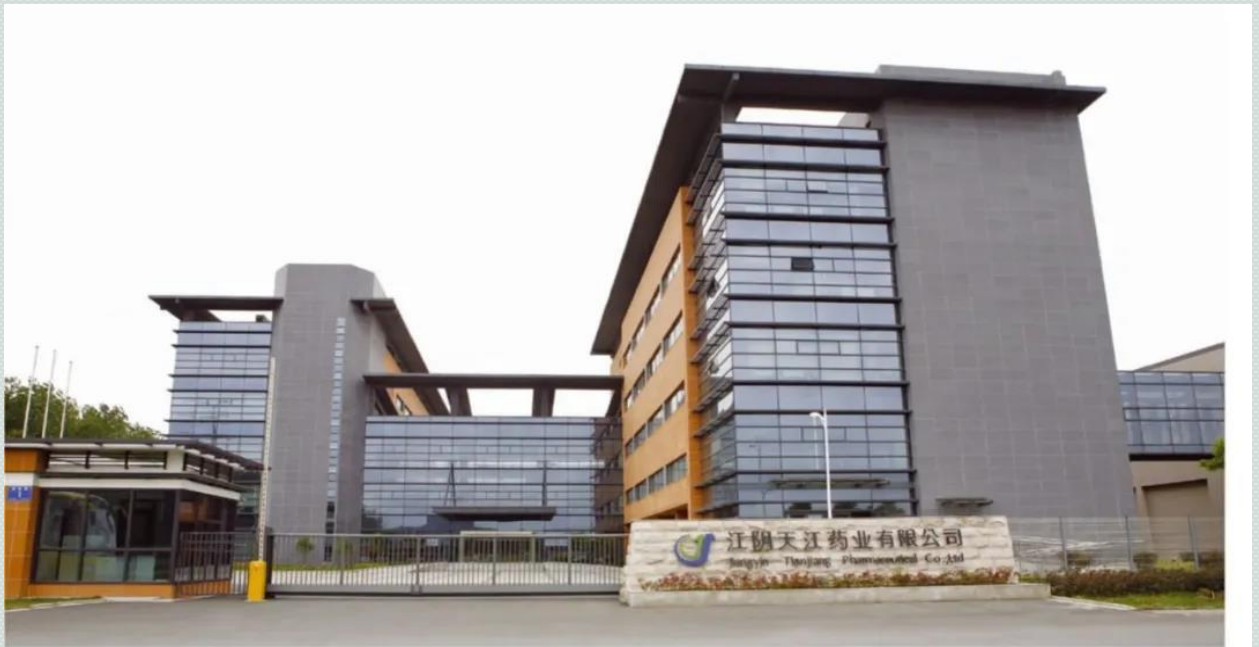
