- Small holes: \$5.00 - 20.00 (up to 5 cm)
- Large holes: \$20.00+ (5+ cm)
- Rip repairs: \$10.00+
- Pocket repair: \$20.00+
- Frayed hem: \$15.00+
- Button replacement: \$15.00+
- Single needle inseam/hem alteration: \$25.00+
- Crotch repairs:
  - Front with small hole: \$30.00+
  - Both front and back: \$45.00+
  - Full rebuild: \$75.00+

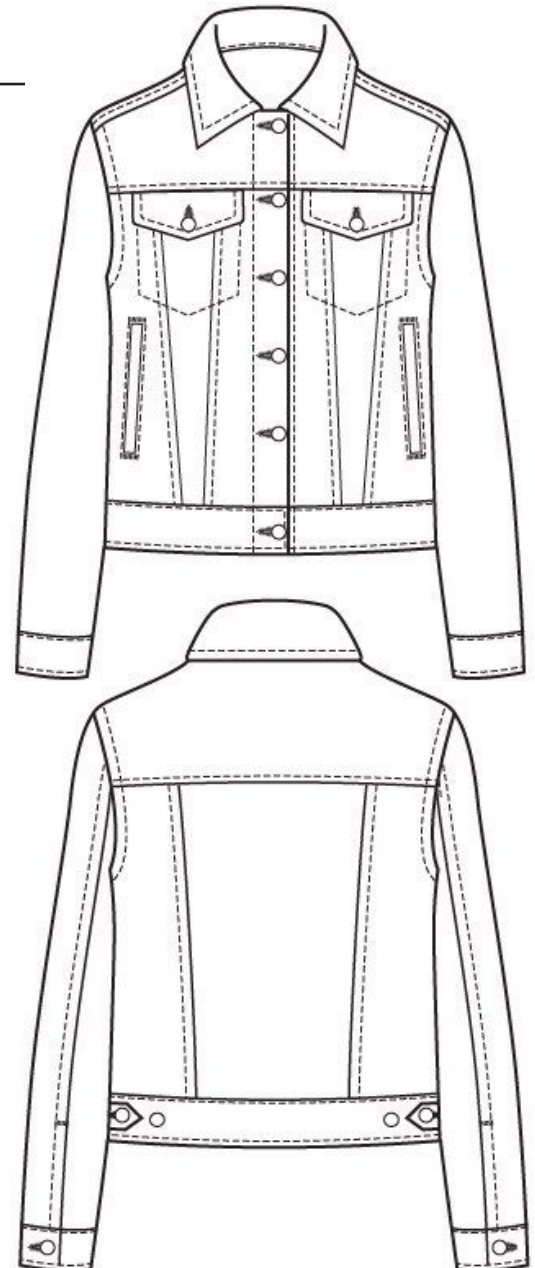
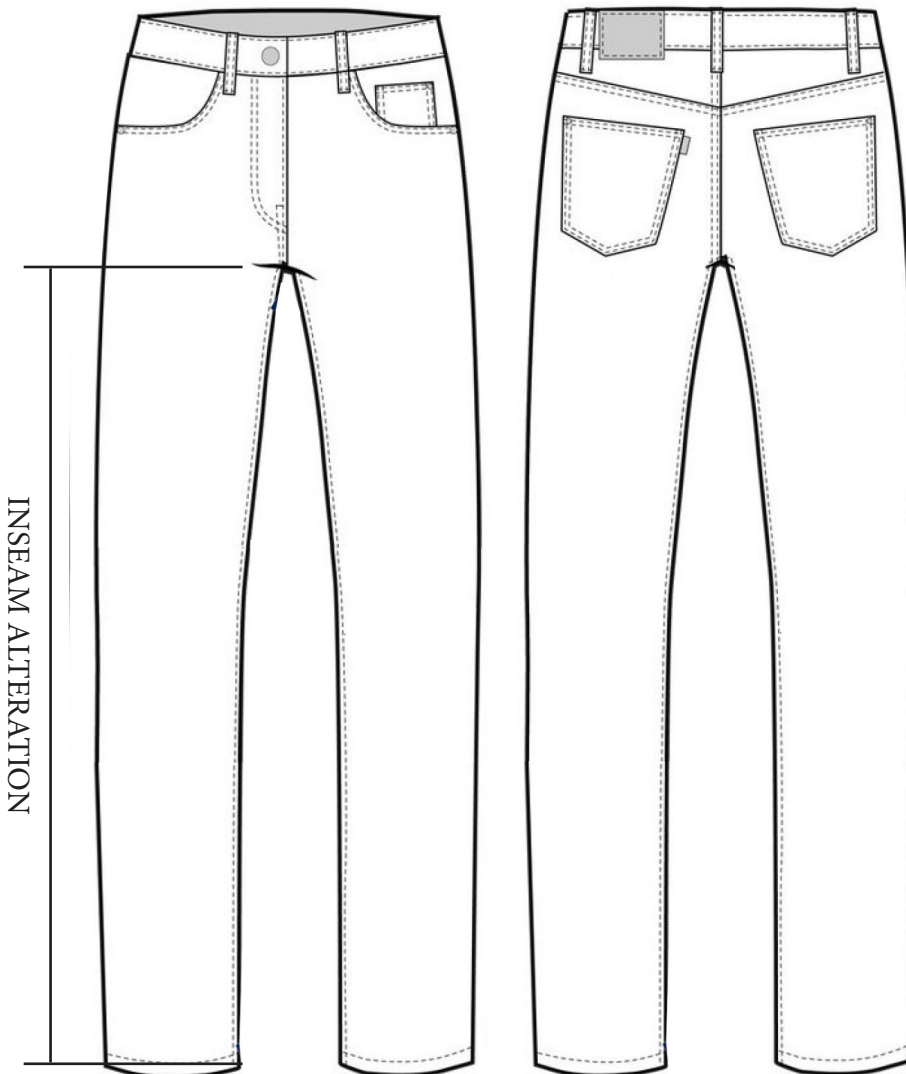

## Release of Liability:

I HEREBY ACKNOWLEDGE AND AGREE that the repair and/or restoration services recommended and provided by The Killer Clothing Collective for my garment(s) carry inherent risks, including but not limited to risks due to the age of the garment, prior treatment, possible incorrect storage, the extent of the age of stains and/or dirt, and history of the garment including, but not limited to, wash and wear of the garment. I agree that The Killer Clothing Collective may provide its recommended treatment or repair, and I assume all risks to the garment, including but not limited to the following:

1. Holes in the fabric after treatment or service;
2. Loss of sheen or loss of "body" after treatment or service;
3. Rusting of buttons or other notions after treatment or service;
4. Stretching or shrinkage of garment after treatment or service;
5. Color of the garment not to the liking after treatment or service;
6. Stains not removed after treatment or service; and
7. The overall repair not to my liking after treatment or service.

I further acknowledge that the above list of damages is not inclusive of all possible risks associated with the garment cleaning, restoration treatment, or repair service recommended or provided by The Killer Clothing Collective and that the above list in no way limits the extent of this waiver and covenant not to collect damages. I voluntarily choose to use the garment cleaning, restoration, and/or repair services of The Killer Clothing Collective.

I waive and release any and all claims that I have or may have in the future against The Killer Clothing Collective, including the owner, operators, employees, agents, affiliates, successors and assigns, and vendors. I further agree that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as the State of Idaho will allow and that if any portion thereof is invalid, it is agreed that the remaining items shall, notwithstanding, continue in full legal force and effect.

This agreement shall be effective and binding upon my heirs, next of kin, executors, administrator and assigns, in event of my death. By signing this agreement, I waive my right to bring a court action to recover compensation or obtain any other remedy for any damage to my property. I agree to pay for all legal fees accumulated by The Killer Clothing Collective incurred by any claims made by me or on my behalf. I agree that any and all legal procedures will be conducted in Nez Perce County, Idaho.
