

MUSICIAN~AUTHOR~FILMMAKER DISTRIBUTION AGREEMENT

Distribution Agreement means that Towards Twenty Fifth Century Living LLC (T25CL) has permission from Artist to distribute submitted Product for MP3 Digital Download, eBooks or Movie Rentals over a 48-hour period. This agreement between T25CL Entertainment, LLC a California Limited Liability Company (herein referred to as T25CL) and Artist for the services of T25CL as a non-exclusive Distributor of said property (ies).

T25CL has permission from Artist to provide MP3 Digital downloads eBooks from the T25CL website only and has permission to play authorized CD music on T25CL Radio in rotation with other selected music. Motion Picture Projects will be available for rental viewing over a 48-hour period. Artist has the right to set price points for their work. Artists will also be asked to be a guest over the Galaxy Talk Show Network. Artist can also request to have his or her own talk show as well over the Galaxy Network. We request that Artist provide a video not to exceed 45 seconds for sending out in a video email over the T25CL Network. Artist can provide email addresses to go into the T25CL database to send out video emails to their fan base as well as the T25CL fan base. Please send email list in the CSV format.

T25CL will upload Artist CD, eBooks or Film Project to the T25CL server and will not be duplicate d for any other purposes for resale other than digital downloads or rentals. T25CL retains the right to leave project on our server for a period of 10 years.

T25CL does not have an exclusive for any work provided by Artist, nor does T25CL have Managerial privileges or own any copy written material provided. T25CL will recommend paid Concerts appearances by Artist. Artist has the option to accept or refuse.

TERRITORY

Territory means United States, Canada, and their respective territories, commonwealths, possessions, and protectorates, including, without limitation, (a) Puerto Rico, Guam, Midway Island, Wake Island, America Samoa, the United States Virgin Islands, St. John, St. Thomas, St. Croix, Bermuda, the Bahamas, Africa, French-speaking Canada, and Newfoundland; (b) airlines and ships, wherever located, flying the flag of The United States or Canada; and (c) all diplomatic posts and work camps, bases, oil rigs and installations and reservations of The Armed Forces of each country located in the "Territory", including the U.S.O. Veterans Administration, Red Cross and similar organizations of each such country.

SALES AND PAYMENTS

Any sales for Digital downloads, eBooks or movie rentals will be allocated 60% for Artists and 40% for T25CL. On the first day of each month T25CL will provide 3rd party print outs for sales of the previous month and all checks will be mailed by the 10th day of the month. All Artists must provide a mailing address, SSI number or Federal Tax ID number. At years end Artist will receive a form 1099 for earnings exceeding \$ 600.00 or whatever minimal designated by IRS. T25CL will not withhold Federal, State, Social Security or Medicare taxes from Artist payments or make such tax payments on Artist behalf. Artist will pay all applicable taxes related to the duties of services under this Agreement. This includes all appropriated taxes as a self-employed independent contractor.

Disputes:

If a dispute arises, the parties will try in good faith to settle it and if not, there may exhaust the option to bring in an outside Mediator/Arbitrator (if deemed necessary by "T25CL) and within that Mediation/ Arbitration try and resolve whatever dispute reasonably and amicably, or reach a mutually satisfactory compromise to resolve the dispute. This will be conducted by a Mediator/Arbitrator that will be mutually selected. Each party will cooperate fully and fairly with the Mediator/Arbitrator. If the dispute is not resolved within 30 days after it is referred to the Mediator/Arbitrator, then it may be followed by legal proceedings. Judgment on the arbitration award may be entered in any court that has jurisdiction over the matter. Costs of arbitration, including lawyer's fees, will be allocated by the arbitrator.

Partnership:

This Agreement does not create a partnership relationship. Neither party has authority to enter into contracts on the other's behalf.

Entire Agreement:

This is the entire agreement between the parties. It replaces and supersedes any and all oral agreements between the parties, as well as any prior writings.

Successors and Assignees:

This agreement binds and benefits the heirs, successors and assignees of the parties.

Notices:

All notices must be in writing. A notice may be delivered to a party at the address that follows a party's signature or to a new address that a party designates in writing. A notice may be delivered:

- In person
- By certified mail, or
- By overnight courier.

Governing Law:

This agreement will be governed by and construed in accordance with the laws of the State of California.
