

- \*Each glass piece is hand blown and may vary slightly in size.

# **QUICK START**

- Fully charge the device before first use.
- Screw the heating chamber onto the Cira base.
- Fill the glass bubbler with water just above the air holes but below the fill line. Do not fill the bubbler while it's attached to Cira base.
- Use the concentrate loading tool to place concentrate into the heating chamber.
- Attach the silicone tether to the cap and the glass, and place the cap on top of the glass.
- · Secure the glass bubbler onto the Cira base.




Attach silicone tether here

\*It is recommended to use Cira fixed onto the charging base and placed on a stable surface to prevent tilting.

- Press the O button for 2 seconds to turn on the device.
- Press "+/-" to adjust to a temperature that fits your consumption needs, then double tap the O button to start the session. The device will start preheating, wait 20 seconds to inhale.

 Press the ① button for 2 seconds again to turn off.




#### Attention:

- The device will go into standby mode when the session ends.
- The device will turn off automatically if no activity is detected for 10 minutes after turning on or in standby mode.
- Cleaning is recommended after each use.

# TEMPERATURE SETTINGS

- Temperature range is from 450-1000°F.
- To adjust temperature
  - Ensure the device is on. Press +/- to adjust temperature.
  - 2. Each temperature level differs by 10°F.
  - 3. Press the  $\odot$  button twice to start heating up when temperature is set.
- During the last 10 seconds of the session, the 15-second extended heating mode can be implemented by double pressing the "+" button.



# **BATTERY & CHARGING**

To charge the device

Connect one end of the charging cable to the charging base and the other end to the charging adapter.



Alternatively, connect one end of the charging cable directly to the device itself and the other end to the charging adapter.



\*Due to safety precautions, the product cannot be used while charging.

Battery Level

The OLED display will show the current battery level when the device is on.

# CLEANING: HEATING CHAMBER

- · Cleaning is recommended after each use.
  - Heat the chamber to remove any residue stuck on the walls of the chamber.
  - Let the chamber cool down to room temperature and unscrew it from Cira base.



Do not handle if hot.

3. Submerge the chamber in 90%+ isopropyl alcohol for over 20 minutes, use a cotton swab to clean gently. Do not use water as there will be mineral residue that may affect the usage of the chamber.



Isopropyl alcohol is highly flammable. Let dry completely before using the device again.

# CLEANING: GLASS COMPONENTS

- Carefully remove the glass bubbler and the cap from Cira base before cleaning.
  - Once removed, soak the glass components in isopropyl alcohol.
  - 2. Rinse clean with water.
  - Allow glass components to dry thoroughly before re-attaching to Cira base.

#### **STORAGE**

- Do not expose the device to direct sunlight, dust, moisture or mechanical shock.
- The device may no longer work properly if dropped.
- This product contains glass components.

  Do not place heavy loads on top or drop it.

# SAFETY

- Do not attempt to disassemble or repair the device as damage or personal injury may occur.
- Keep body parts, clothing, etc. away from the heat source to prevent scalding or damage to personal property.
- To prevent scalding, when the device is heating, do not remove the glass bubbler or touch the heating chamber.
- Use only the power adapter provided with this device to charge it.
- · Do not use the device while it is charging.
- Make sure your hands are dry before touching the charging device to prevent electric shock.
- The device is not water-resistant and not recommended for use outdoors while it is raining, or in other circumstances where it may be exposed to water.
- · Do not use while pregnant or breastfeeding.
- If any abnormality is observed, please stop using immediately and contact a professional after-sales service technician.
