

Statement of Acknowledgment and Understanding

I, (print name here), acknowledge that I have reviewed the
Firearms Course Joining Instructions booklet ("Joining Instructions") prior to the Firearms Safety Course
(the "Course"). I understand the entire contents of the Joining Instructions and I agree to act in accord
with them, as such, solemnly declare the followings:

- 1. I understand that the Course may be taken to obtain a firearms license under the *Firearms Act*, S.C. 1995, c. 39 or to pursue personal interests, however, the Course shall not be taken for other improper purposes;
- 2. (For restricted CRFSC courses) I am least 18 years of age, or will be by the time I attend the first day of the CRFSC course;
- 3. I am not subject to any firearms prohibition order made by any judicial bodies, including a court or a tribunal, in Canada or elsewhere;
- 4. I understand that no live ammunition is permitted at any place where the Course is held and during the time when the Course is being taught. I declare that I will not carry or have under my possession any live ammunition during, immediately before or immediately after the time when the Course is being taught;
- 5. I understand that no alcohol or non-prescribed drug is permitted at any place where the Course is held and during the time when the Course is being taught. I declare that I will not be under the influence of any alcohol or drug during, immediately before or immediately after the time when the Course is being taught;
- 6. I understand that if I have questions or concerns at any time about the Joining Instructions and have a reason to believe that any of the directions provided by the Joining Instructions are not being followed by any other persons, I will consult my instructor, or the employee(s) of Nicoletti & Associates Inc. for clarification or notify them of such non-compliance immediately or whenever appropriate thereafter;
- 7. I understand that courses maybe under video surveillance for student safety and protection;
- 8. I acknowledge that Nicoletti & Associates Inc. may terminate the scheduled Course at any time, with or without cause, and with or without notice. A full refund or credit shall be provided if such termination was caused by Nicoletti & Associates Inc., its vendors, its affiliates or employees, or by any Act of God, insurrection or other foreseeable or unforeseeable cause. If I notify Nicoletti & Associates Inc. in writing of my intention to cancel the registration for the Course before not less than 20 days of the commencement of the Course, I may be entitled to a full refund less administration fees.
