



# **PERFORMANCE ADVANTAGES**

- > Heavy duty, suitable for high traffic areas
- > Quick drying, even at low temperatures
- > Suitable for external or well-ventilated Internal areas
- > Heavy duty chlorinated rubber formulation



## **USES**

- Used on car parks, playgrounds and Industrial floors. Suitable for a wide range of surfaces including bare concrete, asphalt and previously painted floors. It is ideal for areas where a long shut down period would be a problem.
- > Can be brush or roller (solvent resistant) applied.

# **COLOUR RANGE**

> White, Yellow.

# PACK SIZE

> 2.5 litre.

## **SPREADING RATE**

2.5 litres will cover approximately 125 metres of 100 mm wide line.

# **DRYING TIME**

- > Touch Dry in 45 minutes at 20°C.
- > Foot Traffic in 2-3 hours at 20°C.
- > Wheel traffic in 6-8 hours at 20°C.

Curing of the coating can be extended at lower temperatures, dependent on coating thickness, substrate and texture.









#### **PREPARATION**

Ensure surfaces are clean, dry and free from any loose material. Remove any dirt ,oil, surface laitance.

#### **LIMITATIONS**

- > Not recommended for use on newly laid polymer screeds.
- > If in doubt do a small test area.
- ALWAYS conduct a small test area before using on existing paint.

# **APPLICATION**

- > STIR WELL BEFORE USE.
- Please follow the coverage rates shown in SPREADING RATE section.
- > Apply by roller or brush between 5°C 30°C
- As dictated by normal painting practice. In confined spaces, provide adequate ventilation during the Application and drying.

# **CLEANING**

- Remove as much paint as possible from application equipment before cleaning.
- > For cleaning equipment use Britannia Special Solvent (not white spirit).

# **SHELF LIFE AND STORAGE**

- > Up to one year in an unopened original container at Moderate temperatures.
- Store in a safe place in accordance with the instructions in section 7 of the relevant MSDS sheet.

# **PRECAUTIONS**

- > Flammable keep away from sources of ignition.
- > Ensure good ventilation during application.
- > Wear gloves, goggles and suitable protective clothing.
- In case of contact with eyes rinse immediately with plenty of water and seek medical advice.
- Remove splashes from the skin with a recognised hand cleaner or plenty of soap and water.
- > Keep out of reach of children.
- > Do not use near fishponds.
- Harmful to aquatic organisms. May cause long term adverse effects in the aquatic environments.
- > Do not empty into drains.

# **SAFETY**

Keep container in a well-ventilated place. Keep away from sources of ignition. Wear suitable clothing and gloves. Only for use externally or well-ventilated internal areas. The product and container must be disposed of as hazardous waste.
