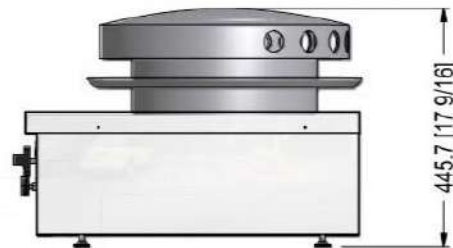
PLAN ELEVATION (1 : 10)
