1. The undersigned acknowledges and agrees that it shall	have no legal estate, right, title or
interest of any kind or character in or to the Dock and that this Agreement shall not be deemed or construed to create such legal rights, it being the intention that the undersigned shall merely have a revocable right and license to use the Dock only in accordance with this Agreement and any rules and regulations announced by KOA, which revocable non-exclusive rights may be revoked or terminated at any time. The undersigned further acknowledges and agrees that permission to so tie-up a boat to the Dock may be granted or withheld at any time and from time to time in the sole and absolute discretion of KOA and that the undersigned agrees to remove any boat so tied up at the Dock (and any personalty related thereto) immediately upon the demand of KOA. In the event the undersigned shall fail to so remove a boat from the Dock at the direction of KOA, the undersigned shall pay a temporary use fee to KOA in a sum equal to One Thousand Dollars (\$1000) per day from the date of demand through and including the date the boat is actually removed by the undersigned. The aforesaid payment shall not entitle the undersigned to any right for the continued use of the Dock and in addition thereto, KOA shall have the right following the failure of the undersigned to remove its boat or other personal property from the Dock, to cause the removal of such boat or personal property from the Dock and KOA shall have no liability or obligation with respect to such action; and the undersigned waives any claim against KOA, its officers, directors, employees or agents in connection with the taking of such removal action.
