Additionally, as a member of the Kennilwood Owners' Association, you are responsible for payment of all dues and assessments pertaining to your property. You will receive periodic billings from the Association for the amounts that are owed, which include annual HOA dues at the beginning of the year and possible special assessments which may be charged at any time. Your prompt payment of those bills will ensure you remain a member in good standing and will contribute to the proper functioning of our Association.

The operations of KOA are conducted by an executive board of directors comprised of elected members of our community who volunteer their time for the benefit of all our residents, and oversee the daily functions and financial responsibilities of the Association.
