



### **INITIAL OBSERVATION:**

While on patrol, Officer Munoz and I were requested by a CNN crewmember to standby as CNN reporter, was being verbally harassed by a group of pro-Trump supporters. The incident took place on the south side of West Allegan Street, south of the Austin Building.

While on standby, I watched pro-Biden supporter, arrive on the scene holding multiple paper signs approximately 18x24 inches in size. He began arguing with pro-Trump supporter, CLORE. During the confrontation, assaulted CLORE by pushing the signs into his face.

#### OFFICER ACTION:

Using my patrol bike, I separated from CLORE. I followed up by backing away from the victim and the other protestors to de-escalate the situation.

#### VICTIM/COMPLAINANT:

D/Sgt. Luebs identified the victim by his driver's license.
