If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

## Basic Services of Funeral Director, Staff and Overhead \$800.00

This is a non-declinable basic fee for our services and overhead and will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for Direct Cremation, Immediate Burial, and Forwarding or Receiving remains.) This fee includes the following:

- Professional staff available 24 hours a day, 365 days a year to respond to initial calls.
- Arrangement conference and coordination of planned services with Cemetery, Crematory and/or other parties involved in the final disposition of deceased.
- Preparation and filing of the death certificate, obtaining proper permits and authorizations, and the primary ordering of the certified death certificates.
- A proportionate share of our taxes, licenses, insurance, maintenance, utilities, equipment, inventory and administrative costs.

College Chapel Mortuary does not offer public viewing.

### No Services - No Preparation, or Viewing of Deceased - Unscheduled Date and Time.

Transportation to Crematory is at the Discretion of College Chapel Mortuary with the Cremains being made available 15 business days from <u>date of the Permit being issued</u>.

If you want to arrange a direct cremation, you can use an alternative container. Alternative materials (with or without an outside covering). The containers we provide are of fiberboard, particle board, and wood alternative containers and caskets.

This basic fee includes services of the Funeral Director and Staff, transfer of decedent to College Chapel Mortuary, minimal preparation as needed for cremation, temperature controlled holding Unit, (additional Fee of **\$65.00** per day will apply after **5 days**), transfer to the crematory, and **Cremation** at **Sunset Retoria**, Benicia, CA not to exceed **250 lbs**. (Transfer of deceased to College Chapel Mortuary includes a **30 mile radius**; additional distance at \$2.75 per mile)

(Transfer of deceased to College Chapel Mortuary and or to a cemetery for a **No Witness** burial includes a **30 mile radius**; additional distance at \$2.75 per mile will apply) This charge does not include preparation of the decedent, use of facilities, merchandise, or other cash advance items.
