## What We Accept:

- Maternity clothing and bras in excellent condition (Items must be maternity/nursing specific)
- Kids clothing sizes newborn to 8 (We will only accept very limited, selective amounts of Carters, George, Joe Fresh, Children's Place, Pekkle, etc)
- Kids shoes sizes newborn-13, youth shoe sizes 1-3
- Sleep sacks and pajamas
- Soft baby wraps and sling carriers.

\*All Items must be freshly laundered, free of any stains or rips, and in season\*

## We Do Not Accept:

- Items that are dated, unwashed, out of season, damaged/overworn, stained or ripped.
- Underwear or socks (unless they are brand new with tags, and unworn)
- Shein, Patpat, or similar brands.

## Selected Items:

- Consigner guarantees that they legally and beneficially own all items, and have full rights to consign them.
- Selected items will be appraised and entered into Consignor's account.
- Selected Items will be photographed and uploaded to jillandjoey.ca within two weeks, but depending on the volume of items we receive it could be slightly longer.
- Items will remain on jillandjoey.ca for a minimum of 60 days. Any items that do not sell by the end of the season in which they would be worn will

be returned to you or donated on your behalf. Jill and Joey is not liable for stolen or damaged items.

#### Sold Items:

Jill and Joey reserves the right to set the sale prices for all consignment items, and the consigner will receive 40% of the sale price.

### **Unsold Items:**

We will contact you by email if your items have not sold and are ready to be returned to you. If the items are not picked up within 14 days, they will be donated on your behalf. (Of course, if you are out of town etc., we will be able to extend that timeline).

## **Collecting Your Portion of Earnings:**

We will automatically pay any consignment earnings above \$50.00 via e-transfer. You may request a payout at any time via our email address: hello@jillandjoey.ca. Payouts may take up to five business days to be processed after your request is submitted. Payout requests under the amount of \$50.00 will be charged a \$1.50 fee. This fee does **not** apply to request for store credit, and does **not** apply if all of your items have sold and we are paying out your total amount owing.

You have the option to accept your payout in the form of Jill & Joey Store Credit at a rate of 50% of the sale price, versus the e-transfer payout rate of 40%. You can contact us for the Store Credit payout at any time, or we will contact you once we owe you \$50.00 or more (at the 40% rate) as usual. We will provide you the option at the time of each payout.

For example, you may accept your payout of \$50.00 at a rate of 40%, or \$62.50 in Store Credit. Store Credit does not expire.

## Terms of this contract:

The terms of this contract may be updated from time to time without the consent of the consignor and shall be binding on the consignor. A copy of our current contract terms are available on our website, and may be sent to you at your request.

This contract replaces and nullifies any previous contracts for your Consignment Account with Jill and Joey.
