# 4. FIRST AID MEASURES

#### 7. HANDLING AND STORAGE

Handling: Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of dust. Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight.
