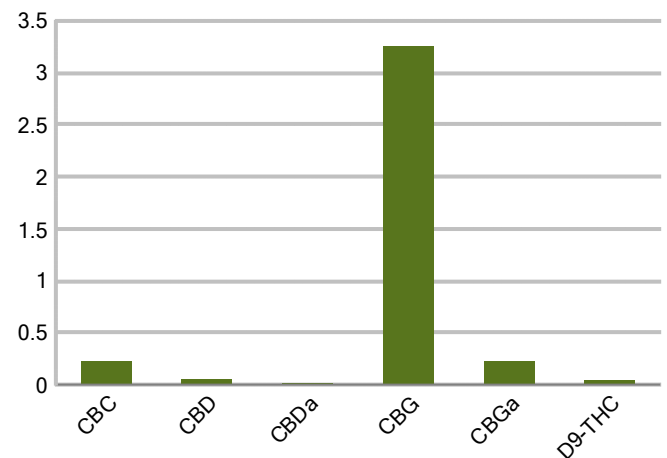

Cannabinoids (% weight)



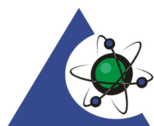
