**Directions:** Spray in well-ventilated areas. Shake well before each use. For best results, apply when surface is dry. Wear safety glasses and gloves when applying.

Apply generously around the perimeter of areas where you are seeing insects. Treat the area with spray several times in the first week. Then maintain application every 30 days. Continue use as needed.

- Spray around entrances (doors and windows)
- Spray around any cracks/entry holes near exterior walls

**Do not** apply on food/feed crops. Do not apply to painted or stained areas. Do not spray near water or near fish areas. Do not apply directly onto edible plants.
