Residential Solar Tax Credit

In accordance with Internal Revenue Code Section 25D, homeowners may be able to deduct a portion of equipment and installation costs of a solar powered gate operator system manufactured by Nice | HySecurity from their Federal Income Tax calculation.

For purposes of the Residential Energy Credit, solar powered gate operator costs are treated as being paid when the original installation of the item is completed and include the cost of any equipment and labor for property that generates electricity for use in your home located in the United States.

Costs include the total installed cost of the solar panel, gate operator, control box, control board, battery, and related accessories such as remote controls, access control devices, entrapment protection devices, and vehicle detectors. Costs do not include the physical gate itself or costs required to make the gate operable (leveling, hinge replacement, etc.) prior to the gate operator system installation.

Qualifications for the Federal Residential Energy Efficient Property Credit:

- The installation cost of a Nice HySecurity solar powered gate operator system
- Effective for tax years beginning after December 31, 2008
- Effective for property placed in service through December 31, 2023
- Use the Federal Tax Credit Form 5695 Residential Energy Efficient Property Credit filed along with your Federal Tax Return forms
- Acquire a copy of the Manufacturer's Certification for Credit for Residential Energy Efficient Property (page 2 below) and maintain for your records
- Only applicable for homes located in the United States and used as a residence by the taxpayer
