

## **POLICY**

GOS International BV has created this privacy statement in order to demonstrate our firm and continuing commitment to the privacy of personal information provided by those visiting and interacting with websites. We hold the privacy of your personal information in the highest regard. The following discloses our information gathering and dissemination practices for our websites.

We recognize the importance of protecting your privacy and our policy is designed to assist you in understanding how we collect, use and safeguard the personal information you provide to us and to assist you in making informed decisions when using our site. We do not share, sell, lend or lease any of the information that uniquely identify a subscriber (such as email addresses or personal details) with anyone except to the extent it is necessary to process transactions or provide services that you have requested.

## **PROTECTED STORAGE**

Access to stored data is password protected and passwords are account specific. Information about the identity and preferences of our contacts is never accessible to anyone outside GOS International BV except as provided hereinbefore. To achieve this level of security, we use Secure Socket Layer (SSL) encryption that encodes information as it is being sent over the Internet. We will maintain safeguards to protect the security of these servers and your personally identifiable information.

## **ACCESS, CORRECTION AND DELETION**
