ON-LICENCE

Sections 14 to 16 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Mt Rosa Wines Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **91 Gibbston Back Road, Gibbston Valley, Queenstown** and known as **"Mt Rosa Wines"**, to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7of Part 2 of the Act.

CONDITIONS

c)

This licence is subject to the following conditions:

- a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person who is not
 - i) residing or lodging on the premises; or
 - ii) present on the premises to dine.
- b) Alcohol may be sold only on the following days and during the following hours:

Indoor Area

Monday to Sunday 8.00 am to 10.00 pm

Outdoor Area

Monday to Sunday 8.00 am to 10.00 pm

- The following steps must be taken to promote the responsible consumption of alcohol:
 - Food must be available for consumption on the premises as follows:

 A range of food choices must be readily available at all times that the premises are authorised to be open for the sale of alcohol. Menus must be visible and food should be actively promoted. A minimum of three types of substantial food must be available. The range or style of food will be as shown on any menu submitted. Alternatively the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads. Food must be suitable for a single customer, at a reasonable price and
 - served within a reasonable time of being ordered.

 The licensee must have a reasonable range of non-alcoholic refreshments and low-alcohol beverages available for consumption on the premises and on any premises where a function or gathering is being catered for.
 - iii) Drinking water must be freely available to customers at all times alcohol is being sold and supplied.
 - iv) The licensee must ensure that signs are prominently displayed within the licensed premises and at any premises where a function or gathering is being catered for detailing information regarding alternative forms of transport from the premises.
- d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed: display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the prohibition on sales to intoxicated persons, identification of minors.
- e) The whole of the premises is designated supervised in accordance with the plans of the premises submitted to the District Licensing Committee on 1st December 2015.
- f) According to the Sale and Supply of Alcohol (Fees) Regulations 2013 the premises is assigned the fees category: Medium Tavern.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) Either
 - i) Until the close of the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either
 - i) Until the close of the period of 3 years after the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 4 years after the day it was issued.
