


Installation Steps



STEP 1


Carefully fold the Tenmat Speaker Cover in gently, push through the pre cut ceiling opening.



STEP 2


Slightly indent a part of the Cover's base to allow the speaker wire to run snug between the Cover and drywall board.

Feed the speaker wire underneath the base of the Cover.



STEP 3

Ensure The Tenmat Speaker Cover has sprung back into its original shape, and sits flush with the backside of the drywall board.



STEP 4

Follow the speaker manufacturer's instructions to properly connect the in ceiling loud speaker. Install speaker according to speaker manufacturer's manual.
