In compliance with the provisions of General Circular No 14/2020 dated April 08, 2020, General Circular No 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020 and General Circular No. 33/2020 dated September 28, 2020 ("MCA Circulars") issued by Ministry of Corporate Affairs and on account of threat posed by COVID-19 pandemic, the Postal Ballot Notice has only been sent through e-mail and the Physical Notice (along with postal ballot forms) and pre-paid business envelope through post have not been sent to the members for this postal ballot.

The Company has on December 10, 2020 completed the process of sending the Notice of Postal Ballot dated December 08, 2020 via emails through National Securities Depository Limited (NSDL) to the members whose email IDs are registered with the Depositories or the Company.
