1. Kindly note that the SEBI vide circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated 3rd November 2021 read with circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated 14th December 2021 has notified simplified **norms for processing investor's service request by RTA and mandated for the physical securities holders in listed company to furnish the following documents/details to the Registrar & Transfer Agent ('RTA') of the company**(Link Intime India Private Limited, 247 Park, C – 101, 1st Floor, LBS Marg, Vikhroli (West), Mumbai (Maharashtra)-400083 , Email: rnt.helpdesk@linkintime.co.in

a) Copy of **PAN** (self-certified)

b) **Nomination:-** Details of nomination shall be provided in hard copy or through electronic mode with e-signature as follows:

i. Either through Form **SH-13** as provided in the Rules 19 (1) of Companies (Shares capital and debenture) Rules, 2014 or 'Declaration to Opt-out', as per Form **ISR-3**

ii. In case of cancellation of nomination/ change in nominee by the holder(s) through Form **SH-14**

As an on-going measure to enhance ease of dealing in securities markets by investors, SEBI vide circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated January 25, 2022 has mandated that listed companies shall henceforth **issue the securities in dematerialized form only** while processing the following service request:

- i. Issue of duplicate securities certificate;
- ii. Claim from Unclaimed Suspense Account;
- iii. Renewal / Exchange of securities certificate;
- iv. Endorsement;
- v. Sub-division / Splitting of securities certificate;
- vi. Consolidation of securities certificates/folios;
- vii. Transmission;
- viii. Transposition;

In relation to above paragraph, the securities holder/claimant shall submit duly filled up Form **ISR-4** (Request for issue of Duplicate Certificate and other Service Requests) along with the documents / details specified therein.
